## NOTIFICATION United Nations Climate Change Talks, Bonn 31 May to 11 June 2010

I wish to notify Parties and observer States to the United Nations Framework Convention on Climate Change and its Kyoto Protocol of the forthcoming sessions under the Convention and its Kyoto Protocol:

- Thirty-second session of the Subsidiary Body for Scientific and Technological Advice (SBSTA 32), 31 May–9 June 2010;
- Thirty-second session of the Subsidiary Body for Implementation (SBI 32), 31 May–9 June 2010;
- Twelfth session of the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol (AWG-KP 12) (precise dates within the sessional period to be confirmed);
- Tenth session of the Ad Hoc Working Group on Long-term Cooperative Action under the Convention (AWG-LCA 10) (precise dates within the sessional period to be confirmed).
