### INFORMATION TO PARTIES

High-level Champions' *Reflections on the way forward* and the Global Climate Action events at the United Nations Climate Change Conference, 2016

### Marrakech, Morocco

This is to inform Parties to the United Nations Framework Convention on Climate Change that the high-level champions, Ambassador Laurence Tubiana and Minister delegate Hakima El Haite, have published their "*Reflections on the way forward*" for Global Climate Action, which may be found at: <a href="http://unfccc.int/paris\_agreement/items/9951.php">http://unfccc.int/paris\_agreement/items/9951.php</a>. This document proposes the next steps to strengthen global climate action in the years leading up to 2018 and 2020. The high-level champions intend to further discuss their proposal during the Conference of Parties to be held in Marrakech, Morocco, from 7 to 18 November 2016 (COP 22). Based on these further discussions, they will provide their recommended way forward to the COP and propose a framework for accelerating global climate action.

In addition, this is to inform Parties that during the Marrakech Conference, Parties are invited to a series of events planned by the high-level champions aiming to mobilize stronger and more ambitious climate action. The high-level champions intend that these events will enable cooperation on the implementation of action to support the achievement of nationally determined contributions. Parties are therefore encouraged to participate in these events and acquire information on best practice and lessons learned and to build networks to support their implementation activities.

On 8 November, an introductory event will take place where the high-level champions will explain their plans for the two weeks of the Marrakech Conference and launch the Global Climate Action events.

The themes of the Global Climate Action events are as follows:

8 November: Forests 9 November: Water

9 November: Industry/Business

10 November: Cities and Human Settlements (Resilience and Buildings)

11 November: Energy12 November: Transport12 November: Oceans

16 November: Agriculture and Food Security.

The **High-Level Event on Accelerating Climate Action** will take place on Thursday, 17 November 2016, and will be the culmination of this series of thematic action events, aiming to demonstrate the progress achieved in the implementation of initiatives and to celebrate new initiatives since COP 21. The high-level champions will present their proposed framework for global climate action at the event. In order to accelerate implementation of identified opportunities, the plenary session of the High-Level Event will be complemented by high-level working sessions. These sessions will be organized by high-level representatives from Parties, non-Parties and international organizations. The champions will be available to attend and to facilitate discussions.
