First meeting of the Adaptation Committee Bangkok, Thailand 7–10 September 2012

Pursuant to decisions 1/CP.16 and 2/CP.17, I am pleased to notify Parties and observer States to the United Nations Framework Convention on Climate Change (UNFCCC) that the first meeting of the Adaptation Committee will take place at the United Nations Conference Centre (UNCC) of the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP), in Bangkok, Thailand, from 7–10 September.

In accordance with the modalities and procedures adopted by decision 2/CP.17, the meeting of the Adaptation Committee will be open to observers, except where otherwise decided by the Adaptation Committee. Given space limitations, participation may have to be limited.

Interested Parties and observer States must register for the meeting using the observer registration form, which is attached as annex I.
