Pursuant to decision 2/CP.20, I am pleased to notify constituencies of admitted non-governmental organizations (NGOs) that the fifth meeting of the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts (hereinafter referred to as the Executive Committee) will take place at the United Nations Campus in Bonn, Germany, from 21 to 24 March 2017.

In accordance with the modalities and procedures adopted by decision 2/CP.20, the meeting of the Executive Committee will be open to admitted observer organizations. Given space limitations, participation will be limited to two representatives for each constituency.

Representatives nominated by the Constituency Focal Point must register for the meeting using the Observer Registration Form for NGOs, which is sent to Constituency Focal Points. Once the Constituency Focal Points confirm the nomination(s), they should forward the registration form to the secretariat using the following email address: **cmantsch@unfccc.int**.

The deadline for registration as an observer is **Wednesday, 1 February 2017**. In view of the need to confirm the arrangements for the meeting as early as possible, please be advised that the secretariat may not be in a position to process observer registrations for NGOs received after this deadline.

Further details on the meeting will be communicated directly to registered observers. Additional information for observers is contained in the annex.
