I am pleased to notify Parties and observer States to the United Nations Framework Convention on Climate Change (UNFCCC) that the seventh meeting of the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts (hereinafter referred to as the Executive Committee) will take place in Bonn, Germany, from 13 to 16 March 2018.

The meeting of the Executive Committee will be open to admitted observer organizations in accordance with the modalities and procedures adopted by decision 2/CP.20. The Executive Committee strives for inclusiveness in its work, yet space and budget limitations may constrain participation.

The deadline for registration as an observer State is Monday, 5 February 2018. IMPORTANT INFORMATION FOR OBSEERVERS

- This registration is **only valid** for the seventh meeting of the Executive Committee.
- Please be advised that the **nominee is responsible** for making his/her own travel, visa and accommodation arrangements.
- All foreign delegates entering the Federal Republic of Germany must have a valid passport.
 Participants requiring a visa are strongly encouraged to contact the appropriate consular authorities as soon as this notification is received. The issuance of a visa for Schengen States may take up to two weeks from the date of submission of the visa application. To facilitate the issuance of a visa, this notification should be attached to the visa application.
- Participants are advised that obtaining a Schengen visa is contingent on the
 participant securing comprehensive insurance that covers the entire stay. If you are
 travelling more than once, it is recommended to directly get insurance that covers the
 time period of all intended stays.
- Consequently, participants are therefore strongly advised to obtain international travel and
 medical insurance to cover themselves from the time they depart for the meeting until the
 time they return.
