## Sixteenth meeting of the Technology Executive Committee 13 – 16 March 2018

Pursuant to the rules of procedure of the Technology Executive Committee (TEC), as contained in annex II to decision 4/CP.17, I am pleased to notify Parties and observer States to the United Nations Framework Convention on Climate Change (UNFCCC) that the 16<sup>th</sup> meeting of the TEC will take place from 13 to 16 March 2018 at the "Altes Abgeordnetenhochhaus" (AHH building) at the United Nations Campus in Bonn, Germany.
