NOTIFICATION

United Nations Climate Change Conference Warsaw, Poland, 11 to 22 November 2013

I am pleased to notify Parties and observer States to the United Nations Framework Convention on Climate Change and its Kyoto Protocol of the forthcoming sessions:

- The nineteenth session of the Conference of the Parties (COP 19), from Monday, 11 November to Friday, 22 November 2013;
- The ninth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP 9), from Monday, 11 November to Friday, 22 November 2013;
- The thirty-ninth session of the Subsidiary Body for Scientific and Technological Advice (SBSTA 39) from Monday, 11 November to Saturday, 16 November 2013;
- The thirty-ninth session of the Subsidiary Body for Implementation (SBI 39) from Monday, 11 November to Saturday, 16 November 2013;
- The third part of the second session of the Ad Hoc Working Group on the Durban Platform for Enhanced Action (ADP 2.3) from Tuesday, 12 November to Thursday 21 November 2013.

The sessions will take place at the Stadion Narodowy (National Stadium), Al. Księcia J. Poniatowskiego 1, 03-901 Warsaw, Poland.

Distribution: To Parties and observer States through National Focal Points for climate change and diplomatic missions accredited to the Federal Republic of Germany.

Protocol Issues

High-level segment of the session

The high-level segment, to be attended by ministers and other senior officials, will be inaugurated during the afternoon of Tuesday, 19 November 2013. Statements by ministers and other heads of delegation will be heard in joint meetings of the COP and CMP on 20 and 21 November. The high-level segment will conclude on Friday, 22 November with the adoption of decisions and conclusions by the COP and the CMP.

Given the number of Parties and the limited amount of time available for statements, it will be necessary to limit the duration of each statement. **The recommended time limit is three minutes**. Statements on behalf of groups, where the other members of the group do not speak, are strongly encouraged and additional time will be provided for these.

The secretariat wishes to inform Parties and observer States that full texts of the official **statements will not be circulated in hard copy in plenary during the high-level segment**. Full texts of the official statements will be posted on the UNFCCC website. In order to have statements posted on the UNFCCC webpage, Parties speaking at the high-level segment are requested to send an electronic file containing the statements to the following e-mail address <<u>external-relations@unfccc.int</u>>.

Credentials of States Parties to the Convention and its Kyoto Protocol

In accordance with rule 19 of the draft rules of procedure being applied (FCCC/CP/1996/2), the credentials of representatives of Parties, as well as the names of alternate representatives and advisers, shall be submitted to the secretariat not later than 24 hours after the opening of the session. Any later change in the composition of the delegation shall also be communicated to the secretariat.

The credentials must be issued by the Head of State or Government or by the Minister of Foreign Affairs or, in the case of a regional economic integration organization, by a competent authority of that organization.

The secretariat wishes to remind Parties that, in accordance with decisions 17/CP.9 and 36/CMP.1, only one set of credentials is necessary to cover the participation of Parties to the Convention and Parties to the Kyoto Protocol in the COP at its eighteenth session and the CMP at its eighth session.

Credentials should be deposited in the External Relations Office, located in the Conference Affairs and Services Offices at the Stadion Narodowy (National Stadium). No other office of the secretariat or of the Host Country is designated to receive credentials.

Observer States to the Convention

States that are not Parties to the Convention are not required to provide their representatives with credentials.
