Catalyse Climate Action



The United Nations Climate Change Secretariat (UNFCCC) and five prominent partners are catalysing action on the ground through regional collaboration centres (RCCs) combining climate change expertise with in-depth local knowledge.

Set up to spread the benefits of the clean development mechanism (CDM), the RCCs have broadened their role since adoption of the Paris Agreement on climate change in December 2015, supporting the development and implementation of countries' nationally determined contributions to climate action under that agreement, with a particular focus on markets and mechanisms.

- Matching activities with sources of finance




