THIRD SESSION OF THE CONFERENCE OF THE PARTIES (COP 3)

A high-level segment to be attended by ministers and other heads of delegation has been scheduled for COP 3 (item 6 of the provisional agenda) from 8 to 10 December 1997. During this high-level segment, ministers and other heads of delegation of the Parties will have the opportunity to make statements at the plenary meetings on Monday, 8 December and Tuesday, 9 December. Meetings will be held for this purpose in the morning (10:00 - 13:00), afternoon (15:00 - 18:00) and evening (19:00 - 22:00) of these days. Representatives of observer States and organizations will also have the opportunity to make statements during this time. The duration of each statement will be limited to five minutes.

The list of speakers for the high-level segment will open on 28 October 1997. During the current sessions of the subsidiary bodies, nominations for the list of speakers will be received by the secretariat from 9:00-13:00 and 14:00-19:00 at the COP 3 desk in the foyer of Grosser Saal.
