Income and budget performance in the biennium 2000-2001

Status of contributions as at 16 July 2001

Note by the secretariat

1. The present text supersedes and replaces that of document FCCC/SBI/2001/INF.3 on the status of receipt of contributions to the UNFCCC trust funds in the biennium 2000-2001.
2. Table 1 lists the arrears from prior years (1996, 1997, 1998, 1999 and 2000), the 2001 indicative contributions, the amounts and dates of payment in 2001, contributions paid in advance for future years and the total outstanding balances due to the Trust Fund for the Core Budget of the UNFCCC.
3. Tables 2 and 3 report on contributions received in the biennium 2000-2001 for the Trust Fund for Participation in the UNFCCC Process and the Trust Fund for Supplementary Activities respectively.

4. Table 4 lists Parties in seven groups according to their status of contributions to the Core Budget, namely:

- (a) Parties having paid contributions up to and including 2001;
- (b) Parties with 2001 contributions outstanding;
- (c) Parties with 2000 and 2001 contributions outstanding;
- (d) Parties with 1999, 2000 and 2001 contributions outstanding;
- (e) Parties with 1998, 1999, 2000 and 2001 contributions outstanding;
- (f) Parties with 1997, 1998, 1999, 2000 and 2001 contributions outstanding;
- (g) Parties with 1996, 1997, 1998, 1999, 2000 and 2001 contributions outstanding.

5. Parties are kindly requested to bring to the attention of the secretariat any errors or omissions in the information presented.
