Status of contributions as at 31 October 2003

Note by the secretariat

1. This document contains information on the status of receipt of contributions to the Trust Funds of the United Nations Framework Convention on Climate Change (UNFCCC) as at 31 October 2003.
2. Table 1 lists the arrears from previous years (1996–2002), the 2003 indicative contributions, the amounts and dates of payment in 2003, contributions paid in advance for future years and the total outstanding balances due to the Trust Fund for the core budget of UNFCCC.
3. Tables 2 and 3 report on contributions received in the biennium 2002–2003 for the Trust Fund for Participation in the UNFCCC Process and the Trust Fund for Supplementary Activities, respectively.
4. Table 4 lists Parties in nine groups according to their status of contributions to the core budget, namely:
 - (a) Parties having paid contributions up to and including 2003;
 - (b) Parties with 2003 contributions outstanding;
 - (c) Parties with 2002 and 2003 contributions outstanding;
 - (d) Parties with 2001, 2002 and 2003 contributions outstanding;
 - (e) Parties with 2000, 2001, 2002 and 2003 contributions outstanding;
 - (f) Parties with 1999, 2000, 2001, 2002 and 2003 contributions outstanding;

- (g) Parties with 1998, 1999, 2000, 2001, 2002 and 2003 contributions outstanding;
- (h) Parties with 1997, 1998, 1999, 2000, 2001, 2002 and 2003 contributions outstanding;
- (i) Parties with 1996, 1997, 1998, 1999, 2000, 2001, 2002 and 2003 contributions outstanding.

5. Parties are requested to bring to the attention of the secretariat any errors or omissions in the information presented.

6. The annex to this document contains details of the new bank account to which contributions should be transferred. This change is a result of the implementation of a new financial management information system and takes effect immediately.

Contributions to the core budget should be paid in United States dollars to the above account specifying “Credit to Account FC-UNFCCC Trust Fund for the core budget”.

Contributions to the Trust Fund for Participation should be paid into the same account specifying “Credit to Account FI, Trust Fund for Participation in the UNFCCC Process”.

Contributions to the Trust Fund for Supplementary Activities including for the “prompt start” of the clean development mechanism (CDM) should be paid into the same account specifying to “Account FR, Trust Fund for Supplementary Activities/CDM”.
