Status of contributions as at 31 October 2005

Note by the secretariat

1. This document contains information on the status of receipt of contributions to the United Nations Framework Convention on Climate Change (UNFCCC) trust funds as at 31 October 2005. For purposes of clarity the status of contributions to the Kyoto Protocol Interim Allocation is reported separately.
2. Table 1 lists all 189 Parties to the Convention and shows the expected and received contributions during 2005 and the net outstanding balances due to the Trust Fund for the Core Budget.
3. Table 2 lists Parties in groups according to the status of outstanding contributions to the core budget for the Convention.
4. Table 3 shows the status of the indicative contributions for 2005 to the Kyoto Protocol Interim Allocation. Parties may note that in some cases the indicative contributions shown in this document differ from the notification of contributions issued on 18 November 2004. This is mainly due to the increasing number of Parties to the Kyoto Protocol since it entered into force on 16 February 2005 – from 131 to 156. The contributions had to be adjusted to redistribute the amount of USD 4,773,819 among all Parties to the Protocol.
5. Tables 4 and 5 report on contributions received in the biennium 2004–2005 for the Trust Fund for Participation in the UNFCCC Process and the Trust Fund for Supplementary Activities, respectively.
6. Parties are requested to bring to the attention of the secretariat any errors or omissions in the information presented.
