- (c) Election of officers other than the Chair
6. *Background:* Pursuant to rule 27 of the draft rules of procedure¹ being applied, the SBI is expected to elect its Vice-Chair and Rapporteur. At its twenty-third session, the SBI elected Ms. Gladys K. Ramothwa (Botswana) as Rapporteur and re-elected Mr. Heorhiy Veremiychyk (Ukraine) as Vice-Chair for its twenty-fourth and twenty-fifth sessions. As Mr. Veremiychyk was elected Vice-President of the Bureau of the Conference of the Parties (COP) at its eleventh session, he resigned from the SBI Bureau. The Eastern Europe Group has nominated Mr. József Feiler (Hungary) to replace him. The nominee represents a Party to both the Convention and the Kyoto Protocol.
7. *Action:* The SBI will be invited to elect its Vice-Chair for its twenty-fourth and twenty-fifth sessions at the opening of the session.

**3. National communications from Parties included in Annex I to the Convention:
synthesis of reports demonstrating progress in accordance with Article 3, paragraph 2,
of the Kyoto Protocol**

8. *Background:* The COP, by its decision 25/CP.8, requested the secretariat to prepare a synthesis of reports demonstrating progress achieved by Parties included in Annex I to the Convention (Annex I Parties) in meeting their commitments under the Kyoto Protocol for consideration by the SBI at its first session in 2006. By the same decision, the COP requested the SBI to use the synthesis as the basis for reviewing progress, by 2005, with a view to providing advice on this matter to the subsequent session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (COP/MOP).

9. *Action:* The SBI will be invited to consider the information contained in the synthesis with a view to recommending a draft decision for adoption by the COP/MOP at its second session.

10. *Background:* In accordance with its work programme for 2003–2007, the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention (CGE) will present its report on the outcomes of its examination of 41 national communications from Parties not included in Annex I to the Convention (non-Annex I Parties), including recommendations on how to improve the preparation of second and, where appropriate, subsequent national communications. The CGE will also report on the results of its regular meetings and the status of implementation of its work.

11. *Action:* The SBI will be invited to consider the information contained in the reports listed below and provide advice to the CGE on its work programme.

12. *Background:* The SBI, at its twenty-third session,² took note of the sixth compilation and synthesis of initial national communications from non-Annex I Parties contained in document FCCC/SBI/2005/18 and Add.1–6 and Add.3/Corr.1; it agreed to consider this document at its twenty-fourth session. The SBI invited Parties to submit their views on the document for consideration at its twenty-fourth session.

13. *Action:* The SBI will be invited to consider the documents listed below with a view to recommending a draft decision for adoption by the COP at its twelfth session.

(c) Provision of financial and technical support

14. *Background:* At SBI 18,³ Parties requested the secretariat to make available to them information on the status of preparation of national communications from non-Annex I Parties, as well as details of the financial support provided to non-Annex I Parties by the Global Environment Facility (GEF) for the preparation of initial and subsequent national communications. At SBI 22,⁴ Parties requested the secretariat to report to the SBI at its twenty-fourth session information on activities of non-Annex I Parties that have yet to submit their initial national communication and/or subsequent national communications, including second national communications that have been completed.

15. *Action:* The SBI will be invited to take note of this information and to provide guidance on matters relating to the provision of financial and technical support for the preparation of national communications from non-Annex I Parties.

5. Financial mechanism (Convention)

(a) Third review of the financial mechanism

16. *Background:* The COP, by its decision 3/CP.4, decided, in accordance with Article 11, paragraph 4, of the Convention, to review the financial mechanism every four years. By its decision 5/CP.8, the COP requested the SBI to initiate the third review of the financial mechanism at its twenty-first session in accordance with the criteria contained in the guidelines annexed to decision 3/CP.4, or as they may be subsequently amended, and to take appropriate measures and report on the outcome to the COP at its twelfth session.

17. The SBI, at its twenty-first session,⁵ invited Parties and intergovernmental organizations to submit to the secretariat, by 15 October 2005, information on their experience regarding the effectiveness of the financial mechanism.

18. In order to perform the review, the SBI, at its twenty-first session,⁶ also requested the secretariat to prepare a synthesis report on the financial mechanism for consideration at its twenty-fourth session. The report should be based on submissions received, the Third Overall Performance Study of the GEF, and other GEF documents, including GEF Council documents relevant to the assessment of the effectiveness of the financial mechanism.

19. At SBI 23,⁷ Parties further agreed to use the reports contained in documents FCCC/SBI/2005/INF.7 and FCCC/SBI/2004/18 as an input to the consideration by the SBI of the third review of the financial mechanism.

20. *Action:* The SBI will be invited to consider the documents listed below with a view to recommending a draft decision for adoption by the COP at its twelfth session.

(b) Special Climate Change Fund

21. *Background:* At SBI 23,⁸ Parties decided to continue consideration of this matter at the twenty-fourth session, on the basis of the draft text⁹ produced at SBI 22.

22. *Action:* The SBI Chair will undertake consultations with Parties to seek an agreement on an approach to drafting a decision on this matter for adoption by the COP at a future session.

6. Financial mechanism (Kyoto Protocol)

(a) Adaptation Fund

23. *Background:* Decision 10/CP.7 established the Adaptation Fund. The COP/MOP, by its decision 28/CMP.1, adopted initial guidance to an entity entrusted with the operation of the financial mechanism of the Convention for the operation of the Adaptation Fund and decided that the Adaptation Fund shall function under the guidance of, and be accountable to, the COP/MOP.

24. The COP/MOP also decided to adopt, at its second session, further guidance on policies, programme priorities and eligibility criteria for the operation of the Adaptation Fund. In order to prepare a draft decision on this matter, the COP/MOP invited Parties to submit to the secretariat, by 13 February 2006, for consideration by the SBI at its twenty-fourth session, their views on:

- (a) Specific policies, programme priorities and eligibility criteria;
- (b) Possible arrangements for the management of the Adaptation Fund.

25. The COP/MOP also invited relevant international organizations to submit to the secretariat, by 13 February 2006, their views on possible arrangements for the management of the Adaptation Fund for consideration by the SBI at its twenty-fourth session.

26. The COP/MOP has, in addition, requested the secretariat to organize, before SBI 24 and subject to availability of resources, a workshop to promote an exchange of views on further guidance for the operation of the Adaptation Fund.

27. *Action:* The SBI will be invited to consider the documents listed below, as well as the outcome of the workshop, with a view to recommending a draft decision for adoption by the COP/MOP at its second session.

(b) Application of the memorandum of understanding between the Conference of the Parties and the Council of the Global Environment Facility

28. *Background:* At SBI 23,¹⁰ Parties decided to continue consideration of this matter at SBI 24, on the basis of the draft text contained in annex I to the report of SBI 23.

29. *Action:* The SBI will be invited to further consider this issue with a view to recommending a draft decision for adoption by the COP/MOP at its second session.

7. Implementation of Article 4, paragraphs 8 and 9, of the Convention

(a) Progress on the implementation of decision 1/CP.10

30. *Background:* The COP, by its decision 1/CP.10, mandated a number of intersessional activities relating to the adverse effects of climate change and the impact of implementation of response measures, the outcome of which will be considered at subsequent sessions of the SBI and at the thirteenth session of the COP (December 2007).

31. *Action:* The secretariat will provide an oral report on the status of implementation of the provisions of decision 1/CP.10 and the SBI may wish to take any action it deems appropriate.

(b) Matters relating to the least developed countries

32. *Background:* The COP, by its decision 4/CP.11, extended the mandate of the Least Developed Countries Expert Group (LEG), under the terms of reference in decision 29/CP.7, and requested the LEG to develop a work programme which includes the implementation of national adaptation programmes of action for consideration by the SBI at its twenty-fourth session. At its meeting scheduled to be held in Dhaka, Bangladesh, from 6 to 8 April 2006, the LEG will develop a work programme for the year 2006 which will be included in the report listed below.

33. *Action:* The SBI will be invited to consider the work programme of the LEG and provide further guidance.

8. Capacity-building under the Convention

34. *Background:* The COP, by its decision 2/CP.10, invited Parties to submit to the secretariat, by 15 February 2006, their views on steps to be taken by the SBI to regularly monitor capacity-building activities undertaken pursuant to decision 2/CP.7, for consideration by the SBI at its twenty-fourth session.

35. By the same decision, the COP also requested the secretariat to prepare a synthesis report on the steps to be taken to regularly monitor capacity-building activities pursuant to decision 2/CP.7 based on views from Parties expressed through the submissions mentioned above, and taking into account the work of the GEF on capacity-building performance indicators for the climate change focal area consistent with decision 4/CP.9, and to make this report available at SBI 24.

36. *Action:* The SBI will be invited to consider the documents listed below and agree on any necessary follow-up.

9. Capacity-building under the Kyoto Protocol

37. *Background:* In accordance with decisions 29/CMP.1 and 30/CMP.1, the frameworks for capacity-building in decisions 2/CP.7 and 3/CP.7 are also applicable to the implementation of the Kyoto Protocol. Furthermore the COP/MOP requested the secretariat to take these decisions into account in preparing its synthesis report on the steps taken to regularly monitor capacity-building activities pursuant to decision 2/CP.7. The documents referred to under agenda item 8 are also relevant in support of the discussion on this agenda item.

38. *Action:* The SBI will be invited to consider the documents listed below and agree on any necessary follow-up.

10. Amendment of the Kyoto Protocol in respect of procedures and mechanisms relating to compliance

39. *Background:* The COP/MOP, by its decision 27/CMP.1, decided to begin consideration of the issue of an amendment to the Kyoto Protocol in respect of procedures and mechanisms relating to compliance in terms of Article 18, with a view to making a decision by its third session. The COP/MOP requested the SBI to begin consideration of the issue at its twenty-fourth session and to report on the outcome to the COP/MOP at its third session.

40. *Action:* The SBI will be invited to begin consideration of this matter.

11. International transaction log

41. *Background:* The COP/MOP, by its decision 12/CMP.1, requested the secretariat to report to the SBI, at its twenty-fourth session, on progress made towards the implementation of the international transaction log (ITL), in particular in relation to the content and timing of the testing and initialization of the registry systems.

42. *Action:* The SBI will be invited to consider a note by the secretariat prepared in response to this request and to provide further guidance on the implementation of the ITL, if required.

12. Arrangements for intergovernmental meetings

(a) Twelfth session of the Conference of the Parties

43. *Background:* The COP, at its eleventh session, noted with appreciation an expression of interest from the Government of Kenya to host COP 12 and COP/MOP 2 and requested the Government of Kenya to provide further information by 31 January 2006. The COP also requested the secretariat to initiate a fact-finding mission to Kenya and to report to the Bureau not later than 15 February 2006 on whether COP 12 and COP/MOP 2 could be held in Kenya, in conformity with General Assembly resolution 40/243. In addition, the COP requested the Bureau to decide on the venue of COP 12 and COP/MOP 2 by 28 February 2006. At the time of preparation of the annotated agenda, the Bureau had not yet taken a decision on an offer from Kenya. Information on this matter will be communicated to all Parties by the secretariat.

44. The document listed below includes a list of possible elements for a provisional agenda for COP 12, as well as suggestions concerning the organization of work of the sessions of the subsidiary bodies, the COP and the COP/MOP. The document also addresses possible arrangements for the participation of ministers and other heads of delegation in the high-level segment.

45. *Action:* The SBI will be invited to consider the possible elements for inclusion in the provisional agenda for COP 12 and provide advice to the secretariat thereon. The SBI may also wish to consider the proposals concerning the organization of the session, contained in the document below, and provide further guidance.

(b) Second session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol

46. *Background:* In accordance with Article 13, paragraph 6, of the Kyoto Protocol, ordinary sessions of the COP/MOP shall be held in conjunction with ordinary sessions of the COP, unless otherwise decided by the COP/MOP.

47. The document listed below includes a list of possible elements for a provisional agenda for COP/MOP 2. The document also contains suggestions concerning the organization of the work of the sessions of the subsidiary bodies, the COP and the COP/MOP.

48. *Action:* The SBI will be invited to consider the possible elements for inclusion in the provisional agenda for COP/MOP 2 and provide advice to the secretariat thereon. The SBI may also wish to

consider the proposals concerning the organization of the session contained in the document listed below and provide further guidance.

(c) Future sessional periods

49. *Background:* There are two issues to be considered under this sub-item:

- (a) The venue of COP 13, which is scheduled to be held from 3 to 14 December 2007
- (b) Dates for the two sessional periods in 2011.

50. *Action:* The SBI may wish to consider inviting interested Parties to present offers to host COP 13 and consider any offers already made. The COP, at its twelfth session, will need to decide on the venue of its thirteenth session. The SBI may also wish to consider the dates for the two sessional periods in 2011 and recommend them to the COP at its twelfth session.

(d) Review of arrangements for the eleventh session of the Conference of the Parties and the first session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol

51. *Background:* The SBI, at its eighteenth session, adopted conclusions concerning arrangements for COP/MOP 1.¹¹ Decisions 17/CP.9 and 36/CMP.1 provided a framework for the organization of COP 11 and COP/MOP 1. Decision 36/CMP.1 requested the SBI, at its twenty-fourth session, to review the arrangements for convening COP/MOP 1 in conjunction with COP 11 and to make recommendations to the COP/MOP on arrangements for future sessions.

52. *Action:* The SBI may wish to consider the issues discussed in the document listed below and to make recommendations to the COP and/or the COP/MOP on arrangements for future sessions.

(e) Organization of the intergovernmental process

53. *Background:* The SBI, at its twenty-second session,¹² agreed to continue its consideration of the organization of the intergovernmental process at its twenty-fourth session in the context of its review of the arrangements made for convening COP/MOP 1 in conjunction with COP 11. The SBI invited Parties to submit to the secretariat, by 15 November 2005, their views on possible options for further improvement of the organization of the intergovernmental process. It requested the secretariat to identify possible options and make proposals on the organization of the intergovernmental process, taking into account the views submitted by Parties and experience gained at COP/MOP 1, for consideration at its twenty-fourth session.

(b) Implementation of the Headquarters Agreement

57. *Background:* The SBI, at its seventeenth session,¹³ requested the Host Government and the Executive Secretary to report, once a year, on progress regarding the implementation of the Headquarters Agreement. The last report was provided to the SBI at its twenty-second session in May 2005.

58. *Action:* A representative of the Host Government and the Executive Secretary will make oral presentations on progress made. The SBI will be invited to consider the information provided and take any action deemed necessary.

(c) Privileges and immunities for individuals serving on constituted bodies established under the Kyoto Protocol

59. *Background:* The COP/MOP, by its decision 33/CMP.1, requested the SBI to continue consideration of this matter at its twenty-fourth session, with a view to preparing a draft decision for adoption by the COP/MOP at its second session. The COP/MOP also invited Parties to submit views on this matter to facilitate discussions by the SBI. The COP/MOP also requested the secretariat to consult the Secretary-General of the United Nations on the issue of ensuring necessary privileges and immunities for individuals serving on constituted bodies established under the Kyoto Protocol, and to report to the SBI at its twenty-fourth session on the outcome of these consultations.
