# I. Opening of the session

(Agenda item 1)

#### Resumption of the fourth session of the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol

1. The resumed fourth session of the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol (AWG) was held at the Bali International Convention Centre, Bali, Indonesia, from 3 to 15 December 2007.

2. The Chair of the AWG, Mr. Leon Charles (Grenada), opened the session and welcomed all Parties and observers. He also welcomed Ms. Outi Berghäll (Finland) as the Vice-Chair of the AWG and Mr. Ephraim Mwepya Shitima (Zambia) as Rapporteur. He stressed that the meeting should provide clarity on the schedule of the programme of work of the AWG and the issues to be considered in 2008 as well as on the time frame within which the AWG should complete its work.

3. The Chair reminded Parties that the agenda for the fourth session had been adopted at the first part of that session, which took place in Vienna, Austria, from 27 to 31 August 2007. He also reminded Parties that, at that meeting, the AWG adopted substantive conclusions on agenda item 3, "Analysis of mitigation potentials and identification of ranges of emission reduction objectives of Annex I Parties".<sup>1</sup>

4. The Chair informed Parties that the resumed fourth session would address only those items of the agenda for the fourth session which were not completed during the first part of that session, namely:

- 2. Organizational matters:
  - (b) Organization of the work of the session;
  - (c) Election of officers.
- 4. Review of work programme, methods of work and schedule of further sessions.
- 5. Other matters.
- 6. Report on the session.

5. Owing to ongoing negotiations, the closing plenary of the resumed fourth session of the AWG was postponed and held on the afternoon of 15 December. This plenary was chaired by the Vice-Chair of the AWG.

## **II.** Organizational matters

(Agenda item 2)

#### A. Organization of the work of the session

(Agenda item 2 (b))

6. The AWG considered this sub-item at its  $1^{st}$  meeting, on 3 December.

7. The Chair proposed that the AWG focus its work during the resumed fourth session on agenda item 4, "Review of work programme, methods of work and schedule of further sessions". The AWG agreed to proceed according to this proposal.

#### **B.** Election of officers

(Agenda item 2 (c))

8. The AWG considered this sub-item at its 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> meetings, on 3, 11 and 15 December, respectively. At the 1<sup>st</sup> meeting, the Chair recalled rule 27 of the draft rules of procedure being applied, whereby the AWG is expected to elect its Chair, Vice-Chair and Rapporteur. The Chair informed the AWG that consultations on nominations were being undertaken and that he would keep delegates informed of progress. In the conduct of these consultations, Parties were invited to recall decision 36/CP.7 and to give active consideration to the nomination of women for elective posts established under the Convention.

9. At its 3<sup>rd</sup> meeting, upon receiving information from the Vice-Chair regarding nominations for vacant posts, the AWG elected Mr. Harald Dovland (Norway) as its Chair, Mr. Mama Konate (Mali) as its Vice-Chair and Mr. Boo-Nam Shin (Republic of Korea) as its Rapporteur. The AWG was informed that the newly elected officers will serve for the fifth and sixth sessions of the AWG.

# III. Review of work programme, methods of work and schedule of further sessions

(Agenda item 4)

#### 1. Proceedings

10. The AWG considered this item at its 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> meetings, on 3, 11 and 15 December, respectively. It had before it documents FCCC/KP/AWG/2007/MISC.3 and

FCCC/KP/AWG/2007/MISC.6 and Add.1. At its 1<sup>st</sup> meeting, statements were made by representatives of 28 Parties, including one speaking on behalf of the Group of 77 and China, one on behalf of the Umbrella Group, one on behalf of the European Community and its member States,<sup>2</sup> one on behalf of the Alliance of Small Island States and one on behalf of the least developed countries. The Chair invited Climate Action Network and the Business Council for Sustainable Energy to make statements.

11. At the same meeting, the AWG agreed to consider this item further in a contact group. At the  $2^{nd}$  meeting, the Chair reported on the contact group's consultations and presented draft conclusions<sup>3</sup> for consideration by the AWG. He informed delegates that, despite having made progress, the group could not reach a conclusion on this item. He noted that further consultations were needed.

12. At the  $3^{rd}$  meeting, the AWG considered further draft conclusions<sup>4</sup> proposed by the Chair and adopted them as amended in the course of the meeting.

13. Also at the 3<sup>rd</sup> meeting, the delegation of Canada indicated that it wished to note, for the record, that it believed it is entirely appropriate to make reference to the scientific findings of the Intergovernmental Panel on Climate Change (IPCC) that were noted at the first part of the fourth session of the AWG, and that it is also important that these findings are put in the correct context. However, it noted that it is not necessary or appropriate to merely note some parts of the relevant paragraphs in the report and that it would like to avoid any confusion or misperceptions that this could create.

#### 2. Conclusions

14. The AWG recalled its programme of work contained in document FCCC/KP/AWG/2006/4 and took note of the views provided by Parties on the timetable to guide the completion of work.<sup>5</sup>

15. The AWG reaffirmed that the completion of its work programme will be advanced primarily through the work of Parties, and that it will coordinate its work with, and draw upon relevant results achieved and work under way in, other bodies and processes under the Convention, especially its Kyoto Protocol, with a view to avoiding duplication.

16. The AWG also recalled that its work should be guided by a shared vision of the challenge set by the ultimate objective of the Convention based on the principles and other relevant provisions of the Convention and its Kyoto Protocol. It noted the usefulness of the ranges referred to in the contribution of Working Group III to the Fourth Assessment Report (AR4) of the IPCC and that this report indicates that global emissions of greenhouse gases (GHGs) need to peak in the next 10-15 years and be reduced to very low levels, well below half of levels in 2000 by the middle of the twenty-first century in order to stabilize their concentrations in the atmosphere at the lowest levels assessed by the IPCC to date in its scenarios. Hence the urgency to address climate change. At the first part of its fourth session, the AWG recognized that the contribution of Working Group III to the AR4 indicates that achieving the lowest levels assessed by the IPCC to date and its corresponding potential damage limitation would require Annex I Parties as a group to reduce emissions in a range of 25–40 per cent below 1990 levels by 2020, through means that may be available to these Parties to reach their emission reduction targets. The IPCC ranges do not take into account lifestyle changes which have the potential of increasing the reduction range. The ranges would be significantly higher for Annex I Parties if they were the result of analysis assuming that emission reductions were to be undertaken exclusively by Annex I Parties. The AWG also recognized that achievement of these reduction objectives by Annex I Parties would make an important contribution to overall global efforts required to meet the ultimate objective of the Convention as set out in its Article 2.

17. The AWG noted the concerns raised by small island developing States and some developing country Parties with regard to the lack of analysis of stabilization scenarios below 450 ppmv of carbon dioxide equivalent. In line with the iterative approach to the work programme, the information referred to in paragraph 16 above will be reviewed in the light of information<sup>6</sup> received by the AWG, including from possible further scientific work on stabilization scenarios.

18. The AWG decided to hold the first part of its fifth session in March or April 2008 and to resume and conclude its fifth session during the first sessional period in June 2008.

19. The AWG decided to organize the work for its fifth session as follows:

- (a) At the first part of its fifth session, the AWG will initiate work on the tasks set out in paragraph 17 (b) (i)<sup>7</sup> of its work programme (FCCC/KP/AWG/2006/4), and take into account the results of an in-session thematic workshop it will conduct on these matters;
- (b) In preparation for the first part of its fifth session, the AWG:

- Requested the secretariat, under the guidance of the Chair of the AWG, to organize the in-session workshop referred to in paragraph 19 (a) above and to facilitate the participation of relevant experts and organizations in this workshop;
- (ii) Reminded Parties and accredited observer organizations of its invitations<sup>8</sup> to submit, by 15 February 2008, their views and information on the means to achieve the mitigation objectives of Annex I Parties referred to in document FCCC/KP/AWG/2006/4, paragraph 17 (b), and for Annex I Parties to include in their submissions information on the potential environmental, economic and social consequences, including spillover effects on all Parties, in particular developing country Parties, of available tools, policies, measures and methodologies available to Annex I Parties. It further invited them to include in these submissions their views on the topics to be covered and the experts/organizations to be invited to participate in the in-session thematic workshop referred to in paragraph 19 (a) above;
- (iii) Requested the secretariat to prepare, by March 2008, an information note on the provisions of the Kyoto Protocol and decisions by the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP) relating to means that may be available to Annex I Parties to reach their emission reduction targets, including: emissions trading and the project-based mechanisms; rules to guide the treatment of land use, land-use change and forestry; and GHGs, sectors and source categories covered;
- (c) At the resumed fifth session, the AWG will:
  - (i) Continue work on the tasks set out in paragraph 17 (b) (i) of its work programme (FCCC/KP/AWG/2006/4), and take into account the outcomes of a round table it will conduct on these matters;
  - (ii) Initiate work on the tasks set out in paragraph 17 (b) (ii)<sup>9</sup> of its work programme (FCCC/KP/AWG/2006/4), and take into account the outcomes from an in-session workshop it will conduct on these matters;
- (d) In preparation for the resumed part of its fifth session, the AWG:
  - (i) Invited Parties to submit to the secretariat, by 15 February 2008, their views on the topics to be covered and the experts/organizations to be invited to participate in the round table referred to in paragraph 19 (c) (i) above;
  - (ii) Requested the secretariat, under the guidance of the Chair of the AWG, to organize the round table referred to in paragraph 19 (c) (i) above, and to facilitate the participation of relevant experts and organizations in this round table;
  - (iii) Also invited Parties to submit to the secretariat, by 21 March 2008, their views and information on methodological issues relevant to matters raised in paragraph 17 (b) (i) and (ii) of document FCCC/KP/AWG/2006/4, as well as on the topics to be covered and experts/organizations to be invited to participate in the in-session workshop referred to in paragraph 19 (c) (ii) above;

(iv) Requested the secretariat, under the guidance of the Chair of the AWG, to organize the in-session workshop referred to in paragraph 19 (c) (ii) above, and to facilitate the participation of relevant experts and organizations in this workshop;

20. The AWG decided to hold the first part of its sixth session in August or September 2008 and to resume and conclude its sixth session during the second sessional period in December 2008.

- 21. The AWG decided to organize its work for the sixth session as follows:
  - (a) At the first part of its sixth session the AWG will:
    - (i) Initiate consideration of information on the potential environmental, economic and social consequences, including spillover effects on all Parties, in particular developing country Parties, of available tools, policies, measures and methodologies available to Annex I Parties;
    - (ii) Adopt conclusions on the tasks set out in paragraph 17 (b) (i) and (ii) of its work programme (FCCC/KP/AWG/2006/4);
  - (b) In preparation for the first part of its sixth session, the AWG requested the secretariat, under the guidance of the Chair of the AWG, to:
    - (i) Compile and synthesize, by July 2008, the submissions referred to in paragraph 19 (d) (iii) above and the material presented at, as well as the outcomes from, the round table referred to in paragraph 19 (c) (i) above;
    - Prepare, by July 2008, a technical paper, with the participation of relevant experts and organizations, including from developing countries, on matters related to the tasks set out in paragraph 17 (b) (i) and (ii) of its work programme (FCCC/KP/AWG/2006/4);
  - (c) At its resumed sixth session, the AWG will:
    - Continue and adopt conclusions on its consideration of information on the potential environmental, economic and social consequences, including spillover effects on all Parties, in particular developing country Parties, of available tools, policies, measures and methodologies available to Annex I Parties;
    - (ii) Revert to and adopt conclusions on the tasks set out in paragraph 17 (a) (i)<sup>10</sup> and (ii)<sup>11</sup> of its work programme (FCCC/KP/AWG/2006/4), and take into account the outcomes from an in-session workshop it will conduct on these matters;
    - (iii) Consider its programme of work and decide on activities to be undertaken during 2009;

- (iv) Initiate consideration of the scale of emission reductions to be achieved by Annex I Parties in aggregate;
- (d) In preparation for the resumed part of its sixth session, the AWG:
  - (i) Invited Annex I Parties to submit to the secretariat, by 5 September 2008, additional and updated available information and data related to the tasks set out in paragraph 17 (a) (i) and (ii) of its work programme (FCCC/KP/AWG/2006/4); and on the scale of emission reductions to be achieved by Annex I Parties in aggregate; as well as on the topics to be covered and the experts/organizations to be invited to participate in the in-session workshop referred to in paragraph 21 (c) (ii) above;
  - (ii) Invited Parties to submit to the secretariat, by 3 October 2008, their views on further activities to be undertaken during 2009, in accordance with the work programme of the AWG;
  - (iii) Requested the secretariat, under the guidance of the Chair of the AWG, to update, by October 2008, the technical paper on information relevant to the mitigation potential and to the identification of possible ranges of emission reduction objectives of Annex I Parties,<sup>12</sup> with the participation of relevant experts and organizations;
  - (iv) Further requested the secretariat, under the guidance of the Chair of the AWG, to organize the in-session workshop referred to in paragraph 21 (c) (ii) above, and to facilitate the participation of relevant experts and organizations in this workshop.

22. The AWG agreed that its seventh and eighth sessions will be held and concluded in 2009. At these sessions, the tasks of the AWG will be to:

- (a) Adopt conclusions on the tasks set out in paragraph 17 (c)<sup>13</sup> of its work programme (FCCC/KP/AWG/2006/4);
- (b) Adopt conclusions on the legal implications arising from the work of the AWG pursuant to Article 3, paragraph 9, of the Kyoto Protocol;
- (c) Forward to the CMP at its fifth session the results of its work on the consideration of commitments for subsequent periods for Parties included in Annex I to the Convention under Article 3, paragraph 9, of the Kyoto Protocol, for consideration by the CMP, with a view to their adoption.

23. In preparation for the resumed parts of its seventh and eighth sessions, the AWG invited Parties to submit to the secretariat, by 15 February 2009, their views on:

(a) Legal implications arising from the work of the AWG pursuant to Article 3, paragraph 9, of the Kyoto Protocol;

(b) The scale of emission reductions to be achieved by Annex I Parties in aggregate and on options for the allocation of the corresponding mitigation effort and their contribution to the global effort to reach the ultimate objective of the Convention.

24. The AWG requested the secretariat to schedule all meetings and activities under the AWG, to the greatest extent possible, in conjunction with meetings and activities of other relevant processes under the Convention and its Kyoto Protocol, with a view to ensuring the efficient use of resources.

25. The AWG noted that its requests to the secretariat, as specified in paragraphs 19 (b) (i), 19 (b) (ii), 19 (d) (ii) and (iv), 21 (b), 21 (d) (iii) and (iv) above, as well as the scheduling of additional sessions (see paragraphs 18 and 20 above), are additional and subject to the availability of supplementary funding. The secretariat informed Parties of supplementary funding requirements.

26. An overview of activities of the AWG is provided in annex I.

#### **IV.** Other matters

(Agenda item 5)

27. No other matters were raised or considered.

#### V. Report on the session

(Agenda item 6)

28. At its 2<sup>nd</sup> meeting, on 11 December, the AWG considered and adopted the draft report on its resumed fourth session.<sup>14</sup> At the same meeting, on a proposal by the Chair, the AWG authorized the Rapporteur to complete the report on the session with the assistance of the secretariat and under the guidance of the Chair.

## **VI.** Closure of the session

29. At the  $3^{rd}$  meeting, on 15 December, the Vice-Chair thanked the delegates for their contributions as well as the secretariat for its support.
