## **Status of contributions as at 15 November 2007**

### **Note by the secretariat**

1. This document contains information on the status of receipt of contributions to the UNFCCC trust funds as at 15 November 2007. For purposes of clarity the status of contributions to the Kyoto Protocol is reported separately from the status of contributions to the Convention.
2. Table 1 lists all 192 Parties to the Convention and shows the expected and received contributions during 2007 and the outstanding balances due to the Trust Fund for the Core Budget. One hundred and seven Parties have paid their contribution for 2007, which represents 95 per cent of the indicative contributions for this year. Parties are listed in table 2, grouped according to their status of contributions paid to the core budget for the Convention.
3. Table 3 lists all 175 Parties to the Kyoto Protocol and shows the expected and received contributions during 2007 and the outstanding balances. Ninety Parties have paid their contribution for 2007, representing 92 per cent of the indicative contributions for this year. Table 4 lists Parties in four groups according to their status of contributions paid to the core budget for the Kyoto Protocol.
4. For the first time the status of the fees for the International Transaction Log has been included. Table 5 reflects the initial fee for 2007, the payments received for this purpose, advances where applicable and the outstanding balances.
5. Tables 6 and 7 report on contributions received in the biennium 2006–2007 for the Trust Fund for Supplementary Activities and the Trust Fund for Participation in the UNFCCC Process, respectively. The various fees paid towards the clean development mechanism and joint implementation are also included in table 6.
