Status of submission and review of fifth national communications

Note by the secretariat

- 1. This note provides information on the status of submission and review of fifth national communications (NC5s) under the Convention and its Kyoto Protocol from Parties included in Annex I to the Convention (Annex I Parties) as at 1 November 2010.
- 2. The Conference of the Parties, by its decision 10/CP.13, requested Annex I Parties to submit their NC5s by 1 January 2010, in accordance with Article 12, paragraphs 1 and 2, of the Convention. Decision 8/CMP.3 requested Annex I Parties that are also Parties to the Kyoto Protocol to include, in their NC5s, the necessary supplementary information required under the guidelines for reporting supplementary information under Article 7, paragraph 2, of the Kyoto Protocol (contained in the annex to decision 15/CMP.1).
- 3. At the time of preparation of this note, and as shown in the table below, the secretariat had received 39 NC5s. All national communications received so far have been posted on the UNFCCC website.¹
- 4. On reviews under the Convention, in accordance with decisions 2/CP.1, 6/CP.3, 11/CP.4, 33/CP.7 and 4/CP.8, national communications from Annex I Parties are subject to in-depth review. For the review of the previous fourth national communications submitted by Annex I Parties, in accordance with decision 7/CP.11, in-country, in-depth reviews of these national communications were organized by the secretariat for those Parties that requested such a review. Two Parties requested such a review, namely Australia and the United States of America. In accordance with the same decision, centralized reviews of fourth national communications were organized for the remaining Annex I Parties.²
- 5. On reviews under the Kyoto Protocol, the guidelines for review under Article 8 of the Kyoto Protocol (contained in the annex to decision 22/CMP.1) specify that each

national communication submitted by a Party included in Annex I shall be subject to a scheduled in-country review. This in-depth review encompasses the review of both the supplementary information under Article 7, paragraph 2, of the Kyoto Protocol and the supplementary information under Article 7, paragraph 1, of the Kyoto Protocol on the minimization of adverse impacts in accordance with Article 3, paragraph 14. In accordance with these guidelines, the expert review teams shall make every effort to complete the individual review of national communications within two years of their submission.

- 6. The secretariat has organized 13 in-depth reviews of NC5s in 2010, and is planning to organize the remaining in-depth reviews of NC5s within two years of their submission, subject to the availability of resources.
- 7. By the time of preparation of this note, between March and October 2010, the secretariat had coordinated 11 in-country reviews of NC5s, namely for: Czech Republic, Denmark, Finland, Hungary, Ireland, New Zealand, Norway, Portugal, Spain, Switzerland and United Kingdom of Great Britain and Northern Ireland. The reviews of the NC5s of Japan and Sweden are scheduled for 8–13 November 2010. While the remaining reviews are planned for 2011, coordinating such a large number of reviews might not be possible, owing mainly to the difficulty of scheduling the reviews stemming from the large number of other meetings convened under the UNFCCC process and to resource constraints.
