Note by the secretariat*

1. The Subsidiary Body for Implementation (SBI), at its forty-first session, invited the Global Environment Facility (GEF) to continue to provide information on its activities relating to the preparation of national communications by Parties not included in Annex I to the Convention (non-Annex I Parties), including information on the dates of approval of funding and disbursement of funds, as well as the approximate date of submission of the national communications, for consideration at SBI 43.¹
2. SBI 42 invited the GEF to continue to provide information on its activities relating to the preparation of biennial update reports by non-Annex I Parties, including information on the dates of requests for funding, approval of funding and disbursement of funds, for consideration at SBI 43.²
