In accordance with past practice at such opening meetings, Groups of Parties and observer organizations will be invited to make brief statements. Statements on behalf of groups will be limited to three minutes and those of observer organizations to two minutes each. Full-length versions of statements may be made available on the UNFCCC submission portal.

Participants are asked to take their seats by 09.45 in Plenary New York so that the meeting can start promptly at 10.00.

The opening plenary of the Subsidiary Body for Scientific and Technological Advice (SBSTA) and subsequently, the Subsidiary Body for Implementation (SBI), will be convened in the same room (Plenary New York) immediately following the opening meeting.
