**OTHER MATTERS REFERRED TO THE CONFERENCE OF THE PARTIES  
BY THE SUBSIDIARY BODIES AT THEIR ELEVENTH SESSIONS**

**Recommendation of the Subsidiary Body for Scientific and Technological Advice**

At its eleventh session, the Subsidiary Body for Scientific and Technological Advice decided to recommend the following draft decision for adoption by the Conference of the Parties at its fifth session:

**Draft decision -/CP.5**

**Research and systematic observation**

*The Conference of the Parties,*

*Recalling* Articles 4.1(g), 4.1(h) and 5 of the United Nations Framework Convention on Climate Change,

*Recalling also* its decisions 8/CP.3, 2/CP.4, and 14/CP.4,

1. *Recognizes* the need to identify the priority capacity-building needs related to participation in systematic observation;
2. *Invites* the secretariat of the Global Climate Observing System, in consultation with relevant regional and international bodies, including the Global Environment Facility, to organize regional workshops on this issue;

3. *Urges* Parties to actively support and participate in these regional workshops;
4. *Invites* the secretariat of the Global Climate Observing System to continue to assist and facilitate the establishment of an appropriate intergovernmental process to identify the priorities for action to improve global observing systems for climate and options for their financial support;
5. *Requests* the Global Climate Observing System secretariat to report on this matter to the Subsidiary Body for Scientific and Technological Advice at its twelfth session;
6. *Urges* Parties to address deficiencies in the climate observing networks and invites them, in consultation with the Global Climate Observing System secretariat, to bring forward specific proposals for that purpose and to identify the capacity-building needs and funding required in developing countries to enable them to collect, exchange and utilize data on a continuing basis in pursuance of the Convention;
7. *Adopts* the UNFCCC reporting guidelines on global climate observing systems;<sup>1</sup>
8. *Invites* all Parties to provide detailed reports on systematic observation in accordance with these guidelines, for Annex I Parties in conjunction with their national communications, pursuant to decision *\_/CP.5*,<sup>2</sup> and on a voluntary basis for Parties not included in Annex I to the Convention;
9. *Invites* the Convention secretariat, in conjunction with the Global Climate Observing System secretariat, to develop a process for synthesizing and analysing the information submitted in accordance with the UNFCCC reporting guidelines on global climate observing systems.
