Should a speaker not be present at his/her delegation's seat at the appropriate time, a slot may be assigned at the end of the day's proceedings (upon request of the delegation).

Delegates are reminded that statements should not exceed the traditional three- to four-minute limit. Parties are encouraged to consider consolidating individual statements into one statement made on behalf of a group of Parties, in which case a time limit of five minutes will apply. Given the large number of statements, we kindly suggest that statements be as brief and concise as possible, with full texts available for distribution (see below for the quantities required). If Parties do not wish to speak but would prefer only to have their statements circulated, the secretariat will make arrangements to distribute the copies and enter the statement in the records of the Conference.

Any changes in the name and rank of the speaker previously communicated to the secretariat should be provided as early as possible so that the speaker's list can be corrected accordingly. Contact persons are Mr. Horacio Peluffo or Carrie Bullington in Plenary 1.

Parties are kindly requested to note that the secretariat is not in a position to accommodate individual requests for changes in a Party's speaking slot. Parties wishing to make a change should arrange to exchange slots with another Party, and jointly notify the secretariat of the agreement that has been reached.

All Parties are kindly requested to provide the conference officers with 20 copies of their statements in advance to meet the needs of the interpreters and the Conference records. Computer facilities for participants

Second Floor Computer Centre (Ruysdael foyer)

The centre is equipped with 150 computers as well as network printers. Each PC has an Internet connection and is installed with commonly used software (MS-Office, WordPerfect, and Internet browsers). Due to the large number of people who may want to use the facilities, participants are kindly requested to be considerate and limit the time spent using the computers.

An **IT Service Centre** is located within the Computer Centre. Staff are available in the centre to assist with any PC or printer which does not work, as well as to make colour copies, transparencies, prints, etc.

Plug and play area

Two adjacent rooms are equipped with special tables at which participants with their personal laptops will find a power supply and Internet connection (RJ45). Participants are responsible for providing their own power adapters and setting up their equipment themselves. Telephones and photocopiers are also available.

Cyber Café Vermeer Lounge

Participants can access their electronic mail accounts using the 20 PCs in this lounge. Dial 4422 for help. No printer is provided in the lounge.
