## I. AGENDA

## II. ANNOTATIONS TO THE AGENDA

2. The first part of the sixth session of the Conference of the Parties (COP 6, part 1) to the United Nations Framework Convention on Climate Change (UNFCCC) was held at The Hague, from 13 to 25 November 2000. It was not possible to conclude negotiations on the Buenos Aires Plan of Action at the session (see decision 1/CP.4).

3. By its decision 1/CP.6, entitled "Implementation of the Buenos Aires Plan of Action", the Conference agreed to suspend its sixth session and it requested the President to seek advice on the desirability of resuming the session in order to complete work and adopt a comprehensive and balanced package of decisions on all issues covered by the Buenos Aires Plan of Action (see FCCC/CP/2000/5/Add.2, section I).

*Report of the Conference of the Parties on the first part of

### 1. Opening of the session

4. The second part of the sixth session of the Conference of the Parties (COP 6, part 2) will resume at 10 a.m. on Wednesday, 18 July 2001, at the Hotel Maritim, Bonn, Germany. It will start with the tenth Plenary meeting, to be opened by the President of the sixth session of the Conference of the Parties, Mr. Jan Pronk, Minister of Housing, Spatial Planning and Environment, Netherlands. Statements will be given by the President of the sixth session, a representative of the host government of the secretariat and the Executive Secretary. The Chairman of the Intergovernmental Panel on Climate Change (IPCC) will be invited to briefly present the recent reports of the IPCC Working Groups.

### 2. Organizational matters

#### (a) Status of ratification of the Convention and its Kyoto Protocol

5. **Background:** The Conference will have before it a status report on the ratification of the Convention and its Kyoto Protocol, including declarations made under Article 4.2(g). This report will confirm which States are Parties to the Convention and therefore eligible to participate in decision-making. During the resumed sixth session, the number of Parties will total 187, including 186 States and one regional economic integration organization. The Conference will also have before it in the same document a status report on the signature and ratification of the Kyoto Protocol. It has already received 34 instruments of ratification or accession.

6. **Action:** The COP may wish to take note of the information contained in the report.

**(d) Election of officers other than the President**

7. **Background:** A nomination for Vice-President of the Conference is still outstanding from the Group of Asian States.

8. **Action:** In accordance with rule 22 of the draft rules of procedure, being applied, the Conference may wish to elect to the Bureau a Vice-President from the Group of Asian States.

**(e) Admission of organizations as observers**

9. **Background:** Article 7.6 of the Convention states, *inter alia*, that “any body or agency, whether national or international, governmental or non-governmental, which is qualified in matters covered by the Convention, and which has informed the secretariat of its wish to be represented at a session of the Conference of the Parties as an observer, may be so admitted unless at least one third of the Parties present object.” Following established procedure, the secretariat will invite those intergovernmental and non-governmental organizations accorded observer status at previous sessions of the Conference to attend the resumed COP 6. The procedure for admission to the Conference will apply only to new applicants for observer status.

10. **Action:** The Conference will have before it a document containing the list of organizations recommended by the Bureau for admission as observers. The Conference is invited to consider and approve this list.

**(f) Organization of work, including the sessions of the subsidiary bodies**

11. **Background:** The Conference will resume negotiations on the implementation of the Buenos Aires Plan of Action, in accordance with decision 1/CP.6 adopted by the Conference at the first part of its sixth session. The COP will meet in conjunction with the fourteenth sessions of the subsidiary bodies (see paragraph 15 below).

12. After hearing a number of statements under agenda item 1, “Opening of the session”, the Conference will take up the organization of work of the session and deal with a number of procedural and substantive matters. A tentative approach and schedule of meetings is contained in annex I, and the list of documents is contained in annex II.

13. The high-level segment attended by ministers and other heads of delegation is scheduled to start on Wednesday, 18 July and end on Friday, 20 July, with a possible extension to Saturday, 21 July. Ministers will be able to participate in bilateral and group discussions and negotiations in an effort to reach agreement on key issues under the Buenos Aires Plan of Action.

Item 9 of the agenda, “Statements”, will not be re-opened at the resumed session. There will be no speakers’ list before the session and no policy statements from the rostrum by representatives of Parties, observer States, or observer organizations.

14. Following consultations, the President will make further proposals on the organization of work of the session and the texts to be considered by the Conference. These proposals will aim to ensure an efficient, transparent and open environment with a view to concluding negotiations and adopting a comprehensive and balanced package of decisions on all issues covered by the Buenos Aires Plan of Action. Negotiations should conclude by the evening of Thursday, 26 July so that the Conference will be able to adopt its decisions in the afternoon of Friday, 27 July.

15. The subsidiary bodies will meet from the afternoon of Monday, 16 July. They are expected to have completed most of their work by the afternoon of Tuesday, 17 July; any outstanding business will be taken up during the second week of the sessional period. The provisional agendas for the fourteenth sessions of the subsidiary bodies have been kept to a minimum to allow delegations to focus on the important political tasks of the resumed session. The provisional agendas of the Subsidiary Body for Scientific and Technological Advice (SBSTA) and the Subsidiary Body for Implementation (SBI), along with the annotations thereto, are contained in documents FCCC/SBSTA/2001/1 and FCCC/SBI/2001/1, respectively.

16. The Bureau of the COP will monitor and guide the work programme of the Conference.

17. The scheduling of meetings during the session is based on the availability of conference servicing facilities during normal working hours. Given the heavy workload of the session, provision has been made for holding two simultaneous meetings, with full interpretation facilities, in the mornings and afternoons of the entire period. It is also anticipated that either formal or informal meetings will be held every evening.

18. **Action:** The Conference will be invited to endorse an approach to the organization of work and a proposed schedule for the resumed session, including deadlines for the completion of the negotiations.

(i) **Adoption of the report on credentials**

19. **Background:** Rule 19 of the draft rules of procedure, being applied, specifies that the credentials of representatives of Parties, as well as the names of alternate representatives and advisers, shall be submitted not later than twenty-four hours after the opening of the session. Any later change in the composition of the delegation shall also be submitted to the secretariat. The credentials shall be issued by the Head of State or Government or by the Minister of Foreign Affairs or, in the case of a regional economic integration organization, by the competent authority of that organization. Parties are requested to provide their representatives with full powers to participate in the session, including authority to adopt an agreement on procedures and mechanisms on compliance supplementing the Kyoto Protocol, to adopt decisions, to vote and to serve as officers of the Conference of the Parties, its subsidiary bodies and as officers of any sessional bodies. In accordance with draft rule 20, the Bureau will be required to examine and report to the Conference on these credentials.

20. **Action:** Based on the report of the Bureau, the Conference will be invited to approve the credentials of the representatives of Parties attending the session. Representatives will be entitled to participate provisionally in the session, pending this decision.

21. **Background:** The negotiations to conclude the Buenos Aires Plan of Action will take place under items 4 and 7 of the agenda. The documents before the Conference are listed below.

22. The President of COP 6 was requested by the Conference to "make proposals for the further development and consideration of ... texts at a resumed session and to seek the necessary advice beforehand in a transparent manner" (see decision 1/CP.6, FCCC/CP/2000/5/Add.2). In this context, he has prepared an unbracketed consolidated negotiating text as an input to the resumed COP 6. This consolidated negotiating text, comprising draft decisions, is designed to help find common ground solutions to the issues that have been under negotiation in the climate change process since COP 4 in Buenos Aires and for which agreement at The Hague proved elusive. The negotiating texts that emerged from the first part of COP 6 remain on the table.

23. The President will, following consultations, make proposals on how the texts will be considered. (See also agenda item 2 (f): Organization of work).

24. **Action:** Following negotiations on the texts, the Conference will be invited to adopt decisions under the relevant sub-items of agenda items 4 and 7.

## **8. Administrative and financial matters**

25. **Background:** By its decision 22/CP.5, the COP approved “the continuation of the institutional linkage of the Convention secretariat to the United Nations, subject to review not later than 31 December 2001, in consultation with the Secretary-General, with a view to making such modifications as may be considered desirable by both parties.” By its resolution 54/222 of 23 December 2000, the United Nations General Assembly also approved this procedure. Following consultations with relevant officials of the United Nations, document FCCC/SBI/2001/5 has been prepared to provide a basis for the Conference and the United Nations General Assembly to undertake such a review. Its main thrust is to recommend the maintenance of the current arrangements for another five years.

26. **Action:** The Conference will be invited to adopt a decision recommended by the Subsidiary Body for Implementation, at its fourteenth session, to extend the current linkage with the United Nations for another five years.

## **10. Other matters**

27. Any other matter for the attention of the Conference will be taken up under this item.

## **11. Conclusion of the session**

### **(a) Adoption of the Report of the Conference of the Parties at its sixth session**

28. **Background:** A draft report of the work of the second part of the sixth session will be prepared for adoption by the Conference at the end of its resumed sixth session.

29. **Action:** In accordance with established practice, the Conference will be invited to adopt the report and authorize the Rapporteur to complete the final report after the resumed session, under the guidance of the President and with the assistance of the secretariat.

### **(b) Closure of the session**

30. The President will declare the session closed.
