Where will you be working

You will be working as part of the Information Systems Delivery sub- programme. Under the general supervision of the Manager, ISD Subprogramme (P5, ITS) you will report to the Information Systems Project Officer (ITS/ISD).

What will you be doing

You will join an established team of software developers and be tasked with elaboration of a robust design and implementation of a complex web system designed to meet the needs of a global audience. You will contribute to the end-to-end development and maintenance of new and existing UNFCCC information systems.
