Travelling from Bonn

By U-Bahn (city tram), please take tram no 63 or 16 and alight at "Hockreuz" station. By bus, please take bus no. 610 from Bonn main bus station (platform B4) and alight at the "Kennedyallee" bus stop. Then cross the Mittlestrasse and walk straight ahead and Ahrstrasse is on your left. By taxi it will take approximately 15 minutes.

Travelling from Bad Godesberg

By U-Bahn (city tram), please take tram no. 63 or 16 and alight at Hockreuz station. By bus, please take bus no. 614 from Rhineallee bus stop and alight at the "Ahrstrasse/Deutsches Museum Bonn" bus stop and Ahrstrasse is across the road. By taxi it will take approximately 10 minutes from Bad Godesberg centre.
