



# **FORUM OF MINISTERS**

- Created in 1982, 1st meeting in Mexico City
- The Dominican Republic as the current president (Argentina-2, Peru-2, Mexico-2, Uruguay, Brazil-2, Trinidad and Tobago, Chile, Cuba, Barbados, Panama, The Dominican Republic)
- UNEP/ROLAC acts as its Secretariat
- Develop and implement a biennium plan
- Inter-Agency Technical Committee (UNEP, UNDP, ECLAC, IDB, WB, WHO/PAHO)



## **FORUM OF MINISTERS**

### **Decision 14 Climate Change**

"To ask ITC to increase its contributions to the countries of the region in activities related to climate change and to support the work of the development of the systematic climate observation network, early warning systems, education and research as well as capacity building activities"

### **Regional Action Plan 2006-2007**

Climate change as one of 8, linked to the Johannesburg Plan of Implementation and and Guiding Goals of ILAC.

## **Climate Change Working Group (Group 7)**

Led by Panama. 22 countries (inc. 8 SIDS) Supported by IDB, The World Bank, ECLAC, and UNDP.
