

**SUGGESTIONS FROM THE EUROPEAN UNION AND ITS 28 MEMBERS STATES TO  
IMPROVE THE STRUCTURE OF THE GENEVA TEXT – SECTION F - FINANCE**

1. The finance chapter currently has 5 headings. We support reordering these 5 headings along the lines of the proposal at the end of the finance chapter.
2. This suggestion is not intended to undo the progress we made so far in the facilitated sessions. It addresses the finance chapter only.
3. Under each of the five existing headings, the paragraphs could be clustered around a few key topics, in order to structure the many issues that are currently scattered under and across the existing headings. These topics are not meant to be (sub-)headings, and of course they do not mean that we would agree on the content of the clustered paragraphs.
4. The following table shows
  - in the left column, in bold the existing headings in the finance chapter, reordered. Also, in normal text, suggested topics
  - in the middle column: suggestions for moving / allocating specific paragraphs in the Geneva text to headings and topics. We started, but it is not yet a comprehensive list . Some paragraphs or their placement may need to be revised in accordance with the current progress of the facilitation.
  - in the right column: explanations
5. This would not prejudice whether paragraphs would go into Agreement or decisions
