

NON-MARKET-BASED APPROACHES AND MECHANISMS

PART I

INSTITUTIONAL ARRANGEMENTS

Parties will use the following non-market approaches and mechanisms for enhancing their mitigation actions and adaptation co-benefits.

JOINT MITIGATION AND ADAPTATION APPROACHES. In their actions, parties can use joint mitigation and adaptation approaches for the integral and sustainable management of forests, as alternative policy approaches to results-based payments, to support the implementation of the activities referred to in decision 1/CP.16, paragraph 70, ensuring the protection of the integrity of Mother Earth, based on decision __COP/21] (*Paragraph 20 Option 2; paragraph 19. VII and paragraph 68 part III*).

COOPERATIVE MECHANISM FOR SUSTAINABLE DEVELOPMENT. [The cooperative mechanism for sustainable development is established to support sustainable development trajectories in developing countries that combine mitigation and adaptation to climate change, linking the provision of finance, transfer and development of technology, and capacity-building, following a needs-based approach] (*paragraph 65.d; paragraph 19. VII, 40.6, 54.2 and 72.3 option i.a.*).

PART II

PURPOSE OF MECHANISMS [*Affirms that the use of mechanisms is to: {para 39 opt 1 39.1 GNT}*]

- a. Mobilize the widest range of potential **efforts investments** for [adaptation and] mitigation **in the context of sustainable development** (*paragraph 6 option 1 and 2, paragraph 25, paragraph 72.3;*
- b. Create incentives **and conditions** for early action;
- c. Incentivize and coordinate effective mitigation [and adaptation] actions [, including those with co-benefits for adaptation] from the broadest range of actors, including the private and public sector, **indigenous people and local communities, considering gender equality**, to support the implementation of this agreement;
- d. Ensure consistency **with collective and** individual [commitments][contributions][actions] **as appropriate;**
- e. [*Be in accordance with the provisions on transparent accounting as contained in section I (Transparency of action and support), in particular to avoid double counting;*] (*{para 39 opt 1 39.1 a. – e. GNT}*)

ELABORATION OF RULES FOR THE COOPERATIVE MECHANISM FOR SUSTAINABLE DEVELOPMENT: Building on the work conducted under the SBSTA regarding the framework for various approaches and non-market approaches, *decides* that the COP [shall], for consideration and adoption by the governing body at its first session:

- a. Create and strengthen synergies between cooperative arrangements and mechanisms established or to be established under the Convention, its related legal instruments and other relevant institutions; (*{para 39 opt 5 39.3 GNT}*)
- b. Develop the scope and functions of the mechanism.
- c. Develop modalities and requirements about eligibility and participation of parties in the cooperative mechanism for sustainable development.
- d. Establish guidelines for providing publicly available information
