- Training of Agricultural Extension Workers on climate dissemination of information to rural farmers (women) using mobile phones
- Research and publication on gender vulnerabilities and adaptation to climate change
- Capacity buildings programmes on sustainable farming for rural women, Gender focal points of Ministry of Environment
