1. What actions would facilitate the implementation and coordination of non-market approaches and enhance linkages and create synergy?



- Work programme should be designed to help Parties deliver their NDCs while generating a range of co-benefits
 - Identify synergistic, holistic, balanced policy approaches Parties have undertaken or plan to take to support them in implementing their NDCs, to leverage and generate mitigation and adaptation co-benefits
 - Identify opportunities for support to Parties in replicating successful initiatives in these thematic areas
 - Make recommendations on ways and means to operationalize outputs, e.g., to Green Climate Fund or to external initiatives aiming to support transformative approaches towards low-emission/low-carbon development pathways.

Use focused thematic areas so solutions are well-tailored to specific challenges



- Work programme to identify initial thematic areas of focus, for example:
 - Opportunities for progressing the reduction, removal or reform of fossil fuel subsidies
 - Opportunities to increase deployment of renewable energy technologies in power generation
 - Opportunities to phase out inefficient and polluting technologies
- Parties to identify further areas of focus

Examples of possible work programme activities



- Identification of synergistic non-market approaches that have proven successful and can be **leveraged** to support the implementation of Parties' NDCs
- Identification of **enabling environments and policy frameworks** to realize these synergies
- Identification of successful **cross-cutting policy approaches**, regulatory approaches and initiatives
- Identification of **opportunities for replication** of successful initiatives
- Identification of **support and assistance available** from the international community; **opportunities for coordination**
- Identification of **ways to engage and address the needs of the private sector, exposed sectors and communities**



- Identification of **measures related to education, training, public awareness, public participation and public access to information that can be instrumental in promoting greater mitigation and adaptation ambition**
- **Identification of barriers and challenges** faced in implementing synergistic measures, in supporting impacted populations and sectors, in achieving just transitions, and in enhancing public and private sector engagement
- **Identification of cooperative approaches or financial initiatives** that are available to support Parties in implementing synergistic approaches

2. How should the draft CMA decision on the work programme guide work under the framework?



- Decision to continue the work through an annexed work programme, and
- Decision to organise work around specific themes
- Annexed work programme, addressing:
 - 1) purpose
 - 2) scope of work programme
 - 3) modalities
 - 4) initial thematic areas for consideration
 - 5) timeframe for consideration; process for identifying additional thematic areas of focus
 - 6) work programme activities
 - 7) outputs and recommendations
 - 8) transparency

3. What should be the organizational arrangements for the framework?



- Best practice sharing approach, through workshops, written submissions, presentation of case studies, technical papers, synthesis reports, workshop summaries, recommendations
- Parties might be encouraged to
 - present on successful synergistic non-market approaches they have identified or employed to promote mitigation and adaptation ambition, to enhance public and private sector participation in implementation of NDCs, or enable opportunities for coordination across instruments and relevant institutional arrangements.
 - report on quantified or unquantified mitigation co-benefits, adaptation co-benefits, health co-benefits, resources raised or released to address other priorities and needs, clean energy or transport development achieved, etc., leveraged from the use of synergistic non-market approaches.
