# Ambition, support and delivery, now and in the future

Informal Ministerial Round Table 5 December 2012

#### **Overview**

The COP 18/CMP 8 President, H.E. Mr. Abdullah bin Hamad Al-Attiyah, has extended an invitation to all Ministers and other Heads of Delegation to participate in an informal ministerial round table.

The President is taking this initiative to stimulate an inclusive and transparent exchange of views among Ministers and other Heads of Delegation and looks forward to a positive and constructive discussion providing critical political direction to future developments.

The event will be open to all Parties. No formal conclusions or summary document will be produced.

The round table will take place on Wednesday 5<sup>th</sup> December 2012 from 11:00 am to 1:00 pm, and will resume from 3:00 pm to 6:00 pm, in the Qatar National Conference Centre. The event will be a ministerial event. The room for the round table will be announced via the Daily Programme and CCTV early in the second week of the sessions.

### Topics of the round table and format of discussions

This Presidential initiative, responds to requests from Parties, and offers the opportunity for Ministers and other Heads of Delegation to address the question: "How can Mitigation, Adaptation and Means of Implementation be strengthened now and in the future?"

The event will be convened by the President. He will invite two Ministers, one from a developed country Party and one from a developing country Party, to facilitate the discussions on the topic of enhanced implementation of national mitigation and adaptation actions. In the afternoon the President will also invite two other similar Ministers to facilitate the continued discussions.

The Ministers will facilitate discussions among Ministers and Heads of Delegation requesting to make an intervention and will moderate the interactions in a manner to ensure a free exchange of views. Parties are not requested to indicate their intention to make interventions prior to the round table.
