Previous COP decisions

Decision 1/CP.16 (2010):

- Building on existing reporting and review guidelines, processes and experiences, establishes a work programme:
 - The revision of guidelines for the review of NC, including the BR, annual GHG inventories and national inventory systems;
- 2/CP.17 (2011): Launch work programme under SBSTA
- Secretariat to enhance coordination between different review processes to ensure effective and efficient processes and procedures.
- 23/CP.19 (2013): Draft review guidelines for BRs, NCs
- General aspects of all reviews; a placeholder for GHG inventories reviews



SBSTA 36–39 and 1st workshop

SBSTA 36, 37 (2012): Initial consideration of work programme	SBSTA 38, 39 (2013): Focused mostly on BR and NC	First technical workshop on GHG inventories (April 2014)
Need to have cost- effective, efficient and practical review process that does not impose excessive burden	The same information submitted in NCs, BRs and inventories should only be reviewed once	Workshop participants developed draft revised review guidelines and the secretariat prepared a workshop report as input to SBSTA 40
Consider past experience	Advanced work on training	



SBSTA 40 in June 2014 (1)

- Deliberated on the status of the revised guidelines produced at the April workshop
- Advanced its work on the guidelines.
- Invited Parties to submit further views and textual modifications on the guidelines, and requested the secretariat to update the guidelines based on these submissions
 - ♦ One submission was received and the draft revised guidelines produced (FCCC/SBSTA/2014/INF.14)



SBSTA 40 in June 2014 (2)

- ❖ Reiterated the need for this workshop to allow further discussion on the outstanding issues and to advance the text of the guidelines.
 - Organize under the guidance of the SBSTA Chair; encourage broad participation
 - ♦ Secretariat to produce a further updated draft of the guidelines (in track changes) and a workshop report as initial input to the discussions at SBSTA 41

Development of formal training programme for BR and NC for consideration at SBSTA 40	Consider further at SBSTA 41 the training program for BR/NC and the program for GHG inventory reviews.
