Impacts of CC in Mauritius

- Temperature Avg temp has risen from 0.74 to 1.1 Deg. Celcius. Projected temp upto 2 deg. Celcius by 2061 – 2070
- Rainfall –Decreasing trend in annual rainfall of 8 % over Mauritius since the 1950s. Further reduction in amount of water by 13 % by 2050
- Sea level rise Acceleration in sea level rise: around 3.8 mm/yr (1998 & 2007) compared to local sea level rose by 2.1 mm/yr. Conservative sea level rise projection is of order 49 cm by 2100.
- Beach erosion- accentuating beach erosion with loss in beach area (about 18,500 m sq over the last 2 decades) and a number of coral bleaching. 50 % of beach loss by 2050.
- Extreme events- increase in the frequency of extreme weather events more frequent torrential rains resulting in flash floods. 11 deaths in Mar 2013

CC Risks and Vulnerabilities

 The Govt of Mauritius has adopted a multipronged aapproch to address the impacts of CC and enhance the resilience of Mauritius. Several priority sectors such like Disaster Risk Reduction and Mgt, renewable energy, water, coastal zones, fisheries, tourism, public infrastructure, , health and agriculture have been targeted and actions are being taken at different levels to reduce our vulneraility and increase our resilience.
