

MANDATE/INSTITUTIONAL ASPECT OF THE NWP


- Operates under guidance of the SBSTA Chair
- Established at COP11
- An agenda item under the SBSTA (negotiations every SBs once a year)
 - Review progress
 - Review annual work plan
 - Provide any new/additional guidance
- Mandates from COP and SBSTA, and specific milestones for the review/stocktake
 - SBSTA 56: Stock take of the operational and institutional modalities of the NWP with a view to assessing the performance and effectiveness of the NWP at addressing knowledge needs relevant to the implementation of the Paris Agreement



SCOPE OF THE WORK

Addressing knowledge needs of Parties:

- Convening partnerships to co-curate, refine, share and close knowledge gaps
- Mobilizing NWP partners to support the LEG in assisting the LDCs to formulate and implement NAPs
- Collaborating with constituted bodies and responding to knowledge needs under the UNFCCC process.



MODALITY OF THE WORK

• Mandates/advice:

- SBSTA and COP mandates
- Advice from the constituted bodies (e.g. Adaptation Committee (AC), Least Developed Countries Expert Group(LEG))

• Implementation:

 The secretariat works under guidance of the SBSTA Chair in collaboration with over 340 plus partners, experts in countries and regions.

CURRENT WORK PLAN AND PRIORITIES

- Closing priority knowledge gaps by fostering collaborative action in subregions through the Lima Adaptation Knowledge Initiative
- Closing context-specific knowledge gaps in thematic areas
- Supporting the work of constituted bodies
- Assisting the LEG in implementing NAP-related activities and providing support to the LDCs
- Sharing information on adaptation knowledge resources and engagement opportunities for NWP partners via Adaptation Knowledge Portal
- Creating opportunities for universities to close knowledge gaps through the UN Climate Change and Universities Partnership Programme

VISION

Closing gaps in knowledge on all aspects of climate change impacts, vulnerability and adaptation in collaboration with Parties, partners and constituted bodies.
