Human rights in Article 12 of the Paris Agreement

- Article 12 states: Parties shall cooperate in taking measures, as appropriate, to enhance climate change education, training, public awareness, public participation and public access to information, recognizing the importance of these steps with respect to enhancing actions under this Agreement.
- The International Covenant on Civil and Political Rights and other international human rights instruments establish that participation and access to information are human rights. This is reaffirmed in the specific context of environmental matters by Rio Principle 10, the Aarhus Convention and the Escazu Agreement.
- Education is also a right. And according to the Convention on the Rights of the Child, children are entitled to education directed toward respect for the natural environment.

Why and how to promote ACE in the implementation of the Paris Agreement

- It is a human rights obligation
- It results in better outcomes (see e.g. Human Rights Council Resolution 35/20, the findings of the IPCC, research on collective land tenure, etc.)
- Key Entry points at the UNFCCC: the Local Communities and Indigenous Peoples' Platform, the Gender Action Plan, ACE, the Guidelines for Implementation of the Paris Agreement.
