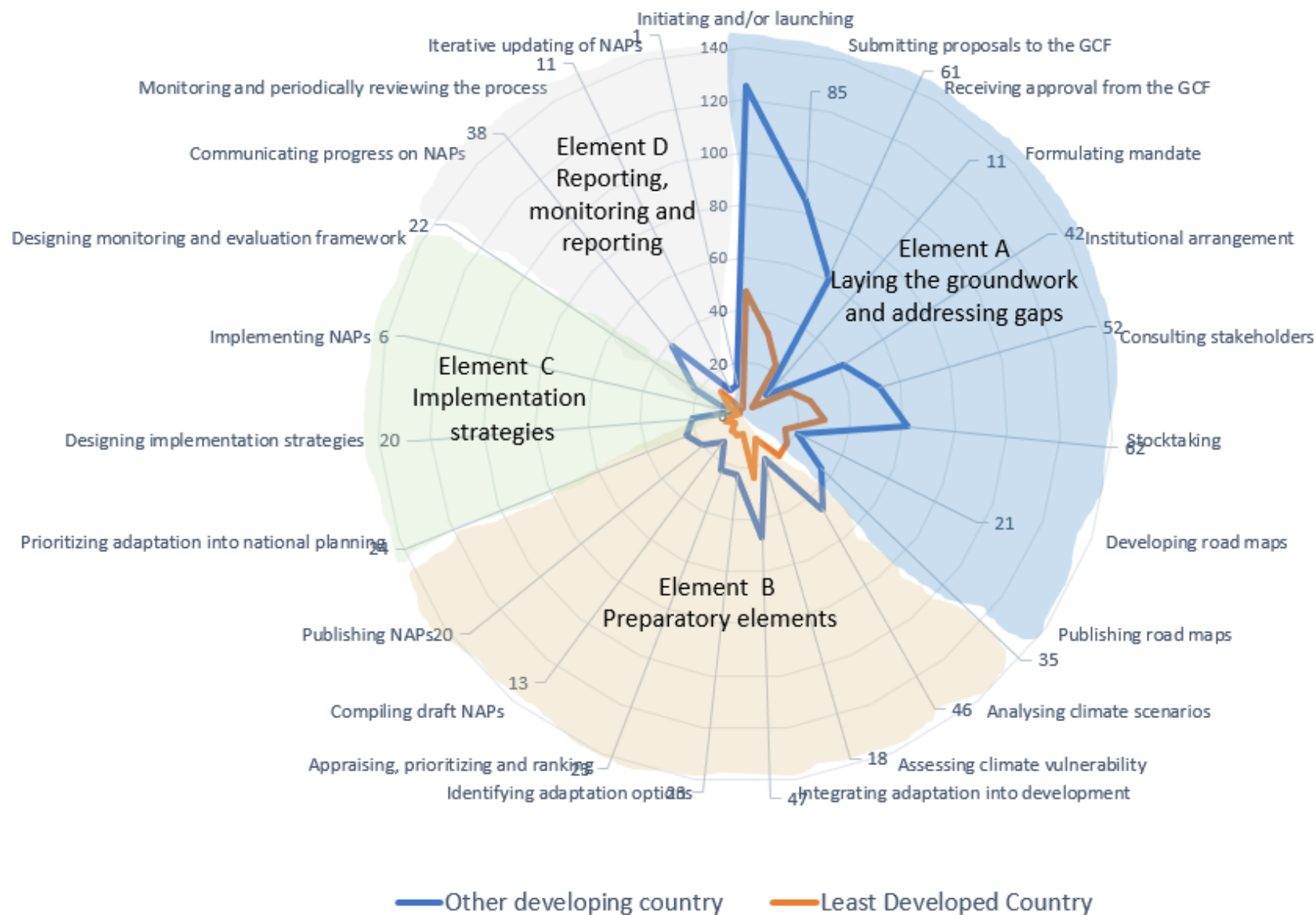

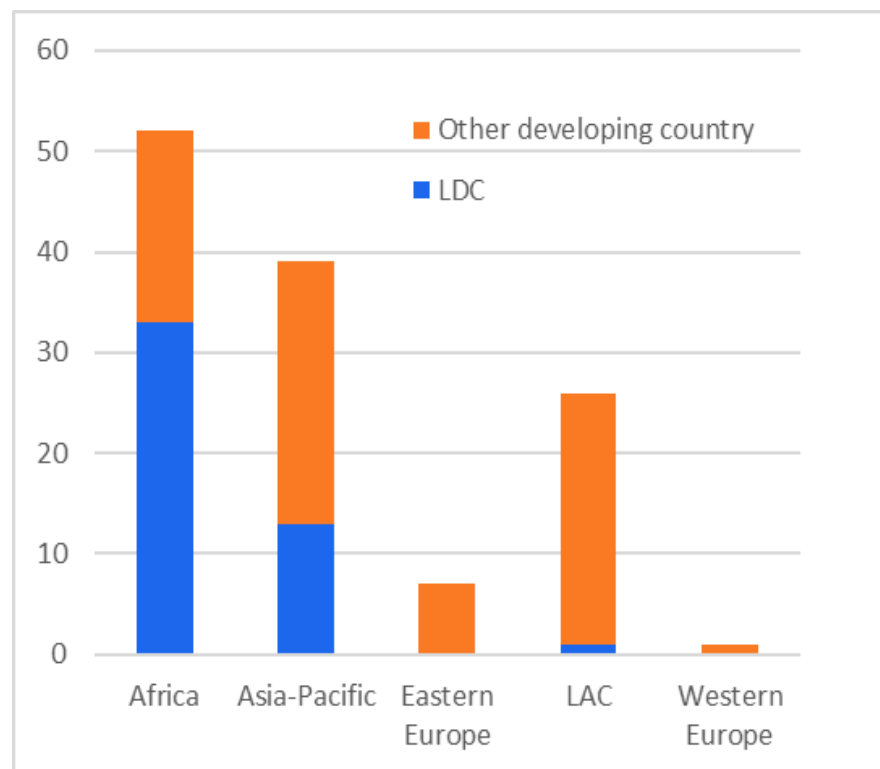

# Measures undertaken in the process to formulate and implement national adaptation plans as at 17 November 2020



## 125 out of 154 developing countries are undertaking the process to formulate and implement NAPs

- 150% increase from 2015 data
- All 47 LDCs are undertaking at least one measure in the process to formulate and implement NAPs
- Out of 125, 55 developing countries are being supported by the GCF for formulating their NAPs while others are being supported in various activities by bilateral partners and other agencies.

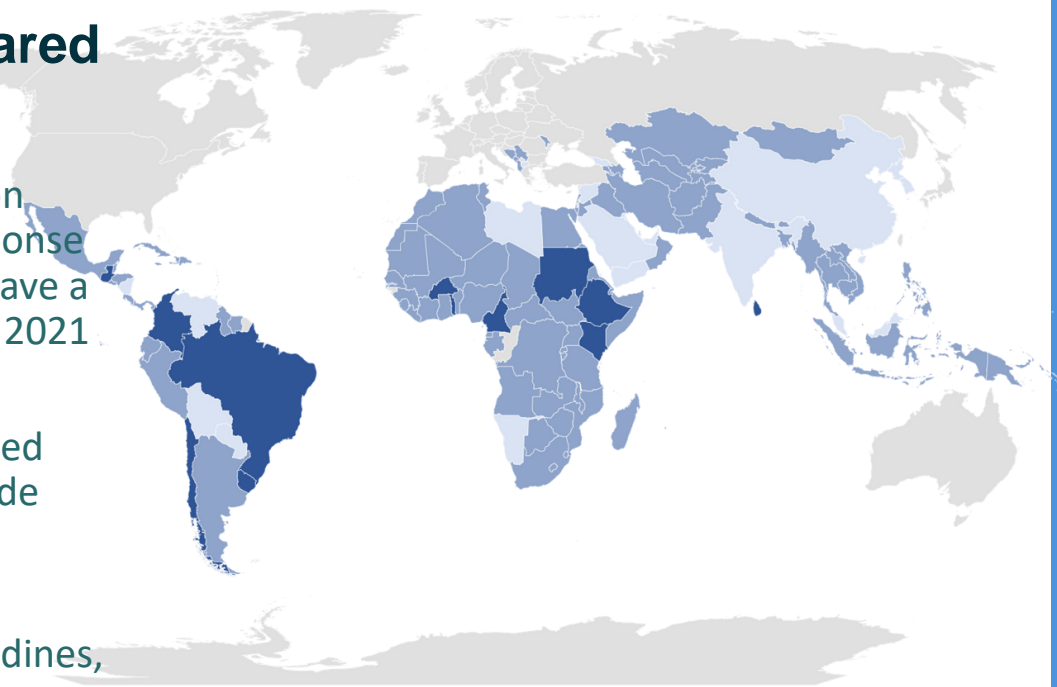


Countries are prioritizing the formulation and implementation of NAPs in their adaptation efforts



## 20 countries, of which 5 are LDCs, had completed preparation of their first NAPs and had shared them on NAP Central

- More LDCs have a draft NAP and are on track in submitting its first NAP in response to the LEG vision of supporting LDCs have a NAP by end of 2020 or first quarter of 2021
- Several countries had completed the preparation of their NAPs and/or related sectoral strategies but had not yet made them available on NAP Central.
- New submission: Grenada, Kiribati, Paraguay, Saint Vincent and the Grenadines, Suriname and Uruguay



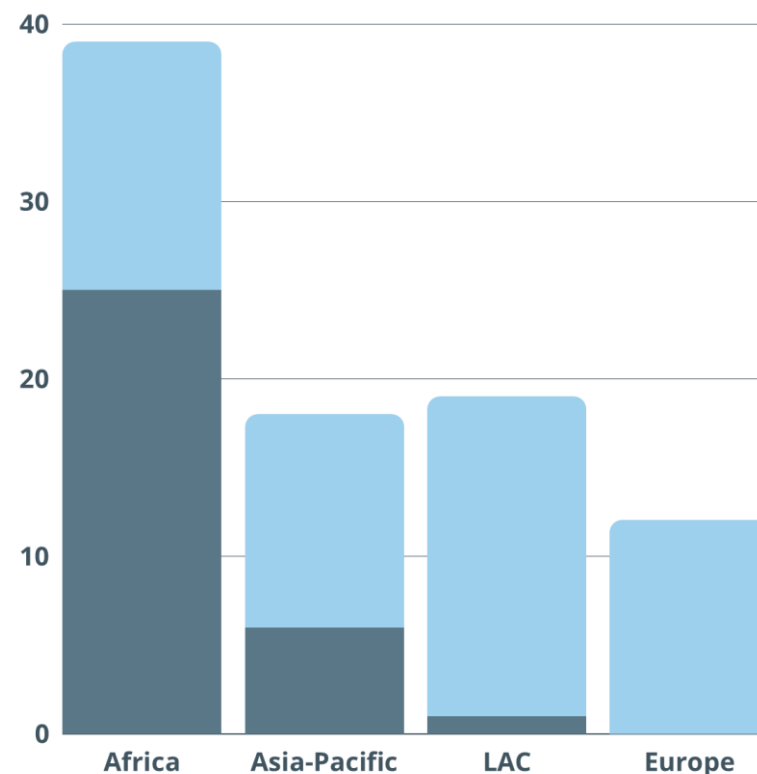

Countries are producing NAPs and many have indicated the submission of the first draft by end of 2020/early 2021



## 85 countries have submitted 88 proposals to the GCF Readiness for NAP formulation; of which 56 are now being supported

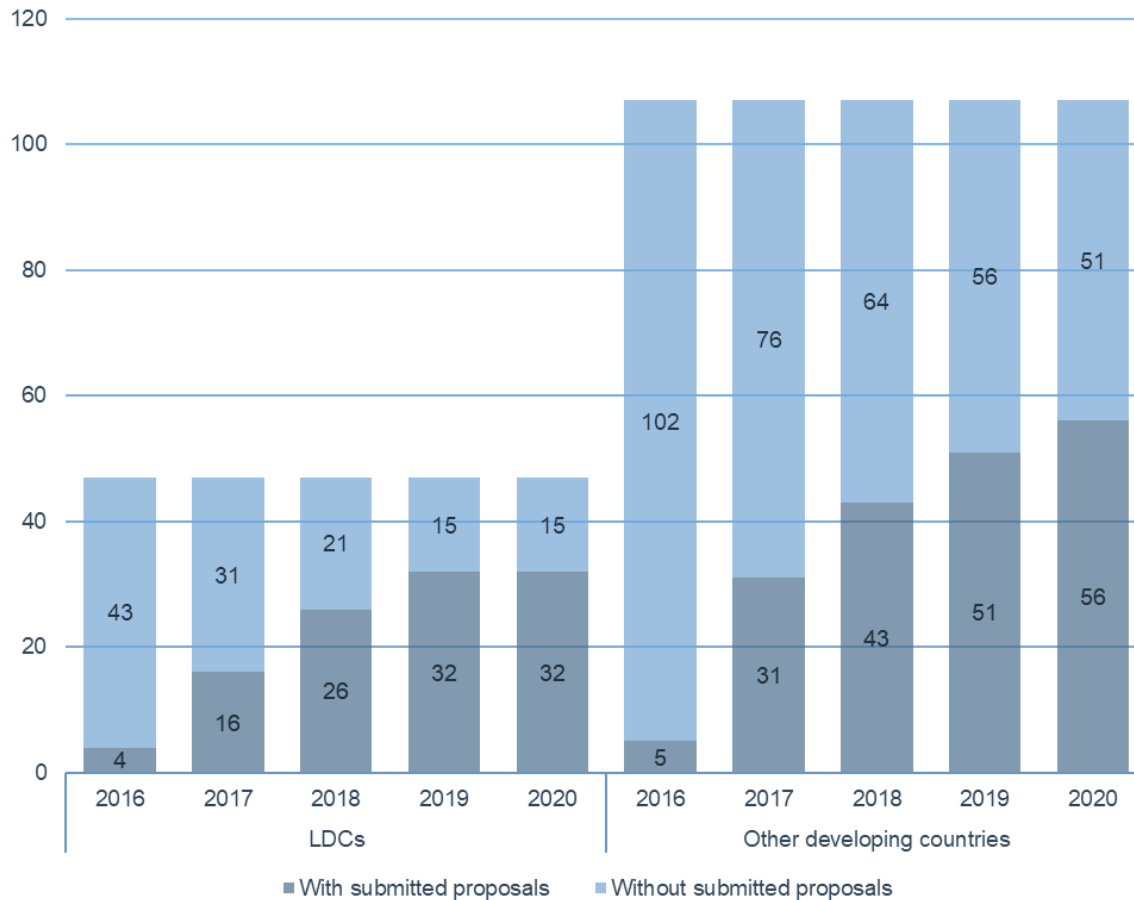
- 10 LDCs had also accessed the LDCF to support activities in support of formulating NAPs
- 3 countries (Belize, Moldova, Tunisia) submitted 2 proposals each
- Africa 39, Asia-Pacific 18, LAC 19, Eastern Europe and Central Asia 12



Countries are accessing funding support for the formulation of NAPs through the GCF readiness support programme



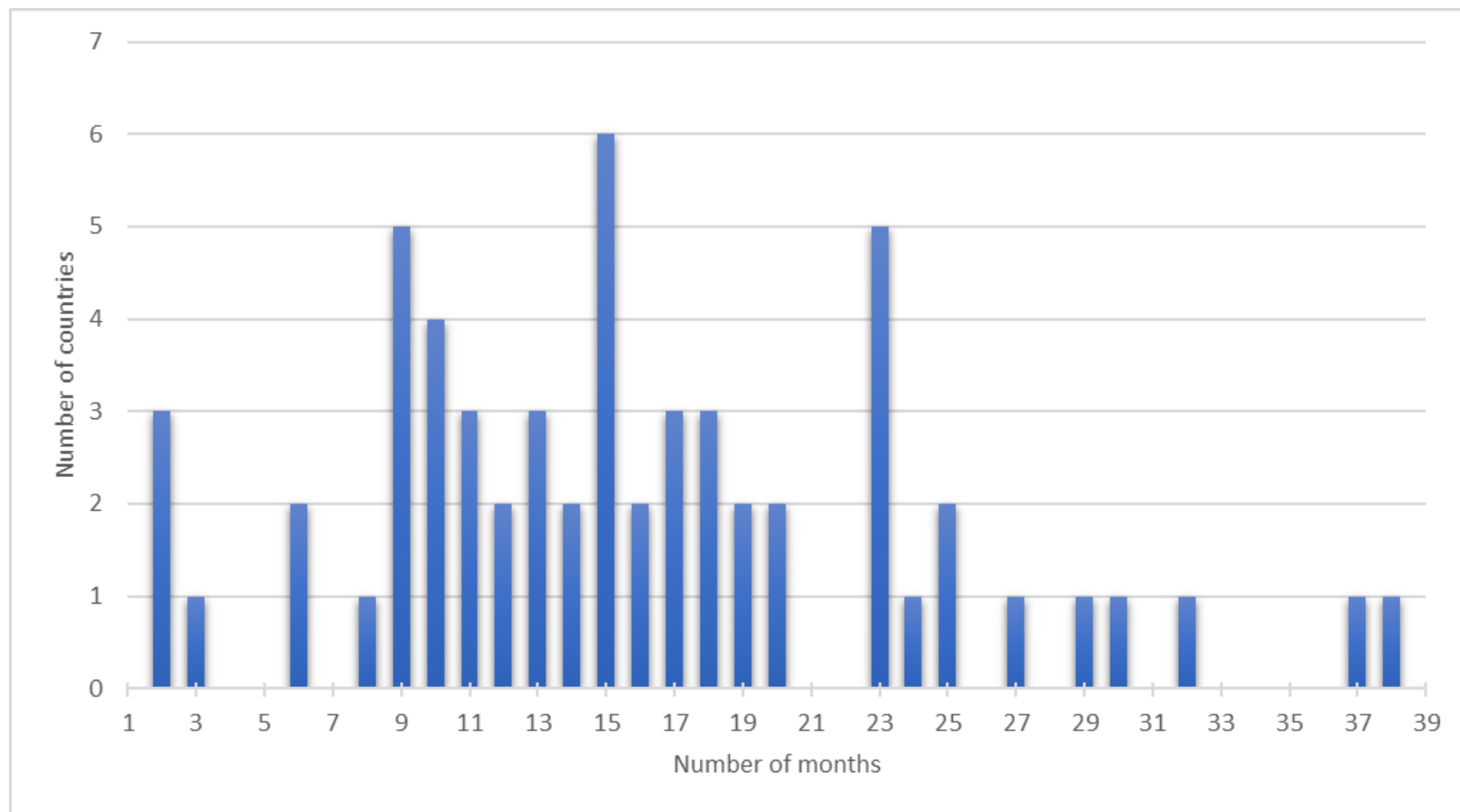




- Of the 47 LDCs, 15 have yet to prepare or submit proposals for GCF
- The progression in the number of developing countries that have submitted NAP readiness funding proposals to the GCF since 2016

31 % of LDCs have yet to prepare or submit proposals for accessing funding from the GCF for formulating and implementing NAPs



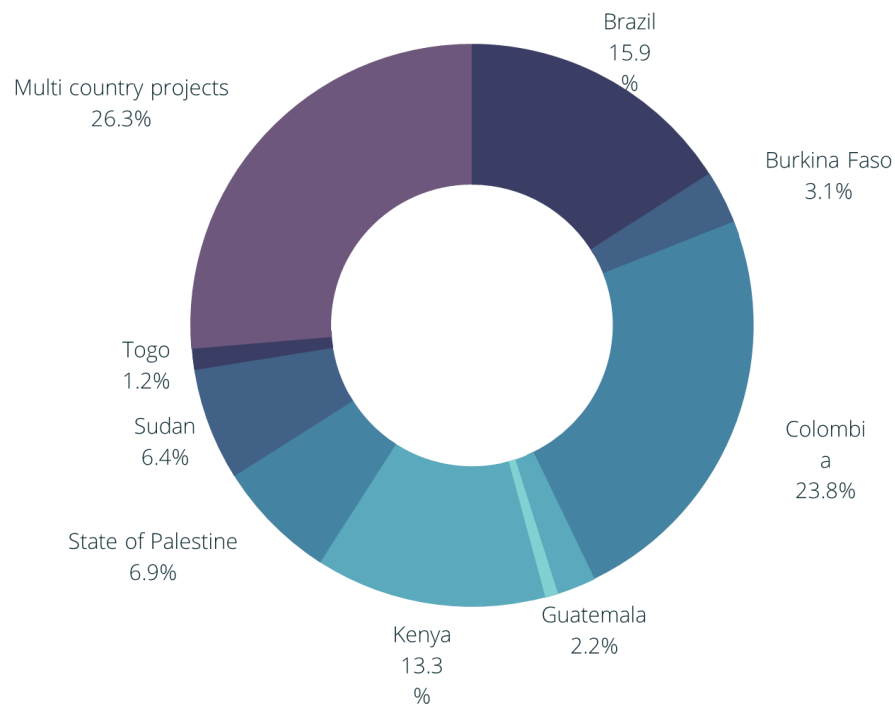


Minimum of 2 months and maximum of 38 months

the gcf readiness and preparatory support programme



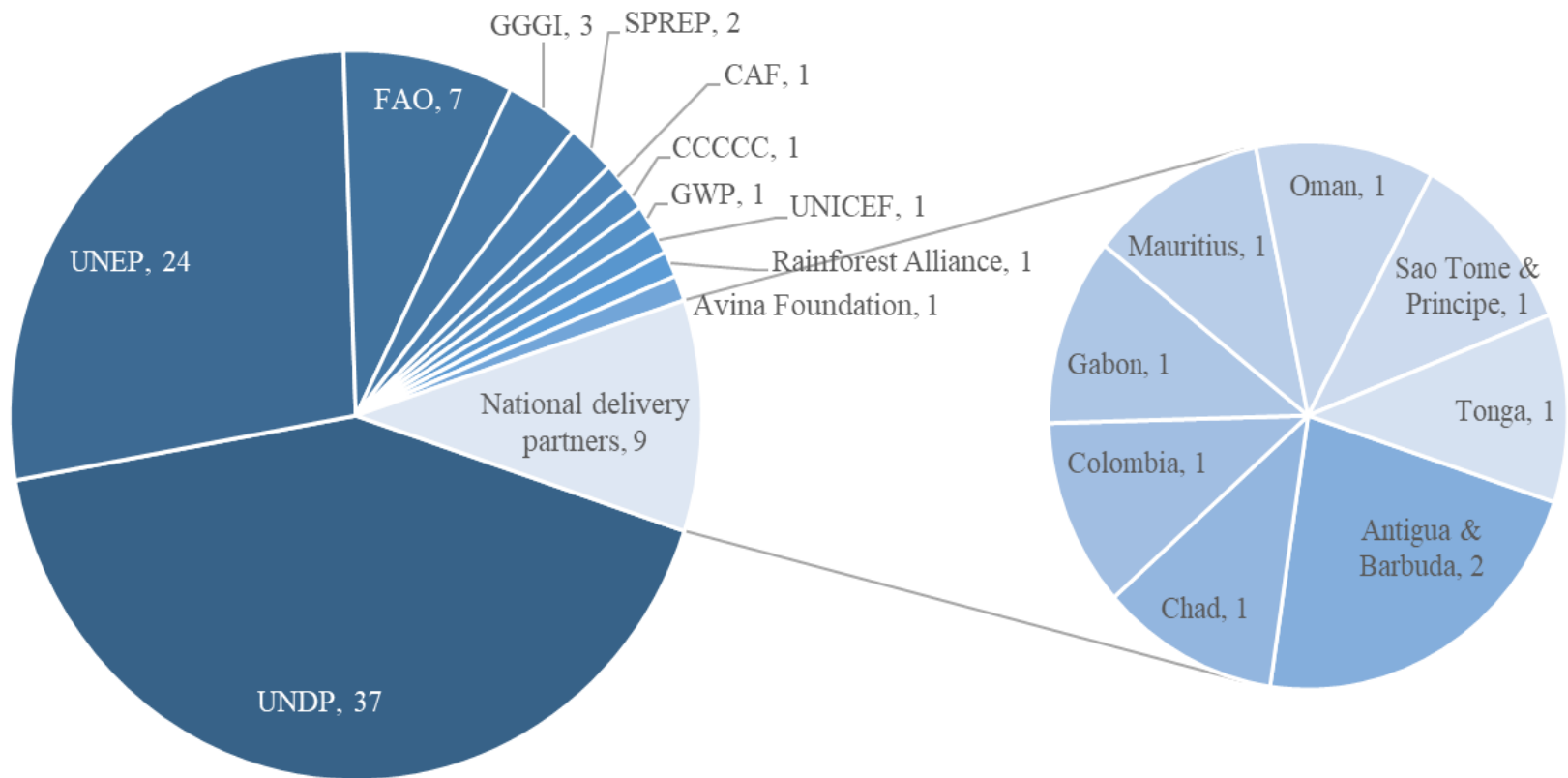
## Seven proposals have been approved to implement priority projects and programmes identified in NAPs, totaling 464 million USD

- Out of the 20 countries with published NAPs, 11 submitted a total of 23 project proposals to the GCF totaling to an estimated of 1.33 billion USD.
- The approved proposals relate to funding for projects addressing climate risks in food and agriculture, energy, health and well-being and water resources.



Several countries are receiving approval of project proposals for implementing their NAPs through the GCF





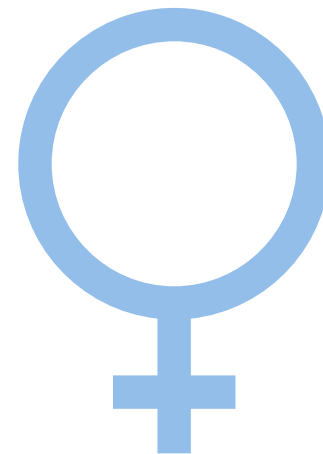
LDCs and other countries are gradually developing capacity for direct access by accrediting national and regional implementing entities/delivery partners

## 18 out of 20 NAPs explicitly mention “gender” and “women”.

- Women are presented in the NAPs as a vulnerable group to climate change (80 per cent), beneficiaries of adaptation action (65 per cent) and/or agents of change (45 per cent).
- Twelve NAPs reference other words or concepts that may represent entry points for addressing gender inequality in the process to formulate and implement NAPs, such as intra- and intergenerational equity, intersectionality and sociocultural characteristics, discrimination and marginalization, socioeconomic inclusion, human rights and empowerment.
- Some countries identified adaptation measures that include gender consideration in their NAPs.



Countries are strengthening gender considerations in the formulation and implementation of their NAPs.



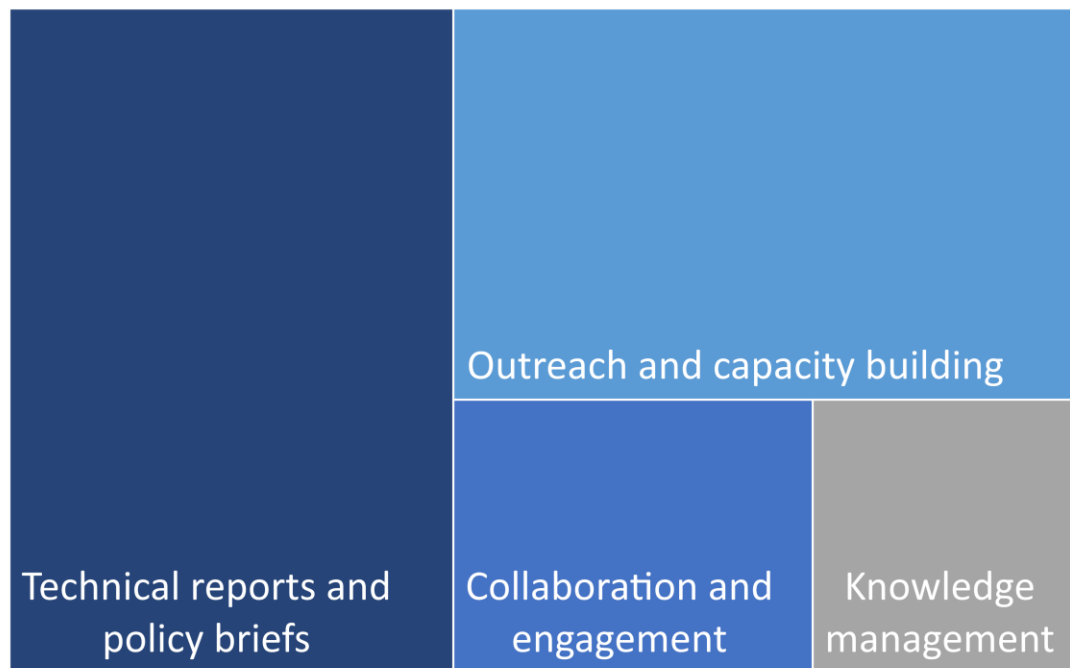
