- **Governance**

Roster of experts, with 182 experts under 3 specializations: accreditation; methodologies; and climate policies.

- **Capacity-building**

15+ Article 6.4 capacity-building activities.

- **Engagement (RCCs)**

1. Onboarding process for six regional experts on Article 6;
2. Note covering capacity-building activities for implementing Article 6 of the Paris Agreement, including detailed RCC efforts.
