Recognising and listening to youth voices with reciprocity means that systems have the capacity and willingness to change.

Young people have always been critical, fearless and unyielding in our advocacy for climate action, and we do things differently from those that have occupied this space before us.

We leverage our resources, our voices, our technologies, anxiety and fear for what may come into strength and power. Our influence can be both in the process and outcome of decisions being made ensuring that we are not only at the table, but have a role in constructing the room where decisions are made.

The Youth Advisory Council on International Climate Change is a diverse group of young Australians aged 18-30 who bring both lived and professional experience in climate action.

The Council was established in 2025 as part of the Australian Government Office for Youth's 'Engage! A Strategy to include young people in the decisions we make'. It has made a space to ensure youth perspectives are integrated into Australia's positions on climate action and heard on a global stage, through the Paris Agreement and **UNFCCC** process.

How we work

We operate through a consensus-based approach, valuing diverse perspectives and delivering practical, forward-thinking recommendations on Australia's climate policies, particularly regarding international engagement.

- Elevating youth perspectives on climate and energy transition policies.
- Building literacy among young Australians around international climate policy.
- Strengthening partnerships between **Australia and Pacific youth on shared** climate priorities.
- Ensuring intersectional approaches to climate action that consider race, class, gender, and geography.

What We See

Young Australians are committed to addressing the challenges posed by climate change. Nearly three-quarters of young Australians believe the federal government must take stronger action on climate change, creating momentum for ambitious climate policies in the new parliamentary term.

To us, youth leadership in the climate space means we can represent the diversity of youth voices, demonstrate why they matter to senior leaders and work collaboratively to create the necessary change.
