# **Report of the Adaptation Committee**\*

Summary

This report covers the work of the Adaptation Committee between October 2017 and October 2018. It contains organizational and procedural information, including information on meetings held during the reporting period and changes in membership and co-chairing arrangements. The report highlights the Adaptation Committee's progress in implementing its flexible workplan for 2016–2018 in the areas of promoting overarching coherence; the technical examination process on adaptation; providing technical support and guidance to Parties on adaptation action and means of implementation; and awareness-raising, outreach and information-sharing. The report also contains the Adaptation Committee's flexible workplan for 2019–2021. It concludes with recommendations for consideration by the Conference of the Parties.

# I. Introduction

## A. Mandate

1. The Conference of the Parties (COP) decided that the Adaptation Committee (AC) shall operate under the authority of, and be accountable to, the COP, which should decide on its policies in line with relevant decisions.1

2. The COP requested the AC to report annually to the COP, through the subsidiary bodies, including on its activities and the performance of its functions, guidance, recommendations and other relevant information arising from its work, as well as, as appropriate, on further action that may be required under the Convention, for consideration by the COP.<sup>2</sup>

### **B.** Scope of the report

3. This report contains information on the work undertaken by the AC between the beginning of October 2017 and the end of October 2018 as well as recommendations for consideration by the COP. The flexible workplan of the AC for 2019–2021 is contained in the annex.

## C. Possible action by the Subsidiary Body for Scientific and Technological Advice and the Subsidiary Body for Implementation

4. The Subsidiary Body for Scientific and Technological Advice (SBSTA) and the Subsidiary Body for Implementation (SBI) are invited to consider the information contained in this report. In particular, they may wish to consider the recommendations contained in chapter V below and to forward them for consideration and adoption at COP 24.

# II. Organizational and procedural matters

### A. Meetings and workshops

5. During the reporting period the AC held its 13<sup>th</sup> regular meeting from 27 February to 2 March 2018 and its 14<sup>th</sup> from 24 to 26 October 2018. Live and on-demand coverage of the meetings was provided via Skype. Both meetings were open to observers.<sup>3</sup>

6. In addition, the AC organized the following events:

(a) A workshop on accessing the Green Climate Fund (GCF) Readiness and Preparatory Support Programme for adaptation (see para. 42 below);

(b) The 2018 Adaptation Forum, organized on the margins of the 2018 Adaptation Futures conference<sup>4</sup> (see para. 45 below);

(c) An expert meeting on national adaptation goals and indicators and their relationship with the United Nations Sustainable Development Goals (SDGs) and the Sendai Framework for Disaster Risk Reduction 2015–2030, held on 24 and 25 July 2018 in Tokyo (see paras. 35–37 below);

(d) A workshop on fostering private sector engagement in building resilience to climate change (see paras. 43 and 44 below).

7. Furthermore, the AC co-organized with the Least Developed Countries Expert Group (LEG) a meeting of Party experts, held from 7 to 9 February 2018 in Sao Tome, to consider progress, experience, best practices, lessons learned, gaps and needs, and support provided and received in relation to the process to formulate and implement national adaptation plans (NAPs) with a view to providing a summary of progress towards achieving the objectives of the process.<sup>5</sup>

8. Finally, a one and a half day technical expert meeting (TEM) in the context of the technical examination process on adaptation (TEP-A) took place on 9 and 10 May 2018 (see paras. 49 and 50 below).<sup>6</sup>

9. AC 14 agreed that AC 15 will be held within the week of 18–22 March 2019 and AC 16 within the week of 23–27 September 2019.

10. The AC welcomed with appreciation the support for its work provided by the Governments of Egypt, Germany and Japan, the European Commission, the United Nations Office for Disaster Risk Reduction and the International Trade Centre. It noted with concern, however, the significant gap between the number of tasks and responsibilities assigned to it and the amount of resources available for carrying out its work.

#### **B.** Chairing arrangements and membership<sup>7</sup>

11. Pursuant to decisions 2/CP.17 and 16/CP.19, Mr. Donald Lemmen continued as Co-Chair of the AC for his third term following his re-election at AC 11. At AC 13, Ms. María del Pilar Bueno was elected for her first term as Co-Chair, replacing<sup>8</sup> Mr. Clifford Mahlung.

12. COP 17 decided that AC members should serve for a term of two years and be eligible to serve a maximum of two consecutive terms of office.<sup>9</sup> Ms. Meredith Ryder-Rude, Ms. Liu Shuo and Ms. Iryna Trofimova were elected as first-time members at COP 23.

13. The terms of office of two other members came to an end before AC 13 and the nominations for those positions are still open.<sup>10</sup> The positions are currently held by Mr. Damdin Davgadorj and Ms. Renske Peters.

14. In welcoming its new members, the AC recalled decision 2/CP.17, paragraph 101, which stipulates that members serve in their personal capacity.

### C. Working arrangements

15. In addition to attending the regular meetings of the AC, members also work intersessionally via electronic means to advance work on particular topics in dedicated working groups established to address a range of agreed priorities. Members are required to allocate a certain amount of time to such essential intersessional work throughout the year. Depending on the estimated duration of their respective tasks, the working groups can be either short term and informal, or more formally arranged with specific terms of reference, as in the case of the NAP task force and the working group on TEP-A, which consist of members of the AC and other constituted bodies under the Convention, as well as, in the case of the TEP-A working group, representatives of non-governmental organization constituencies.

16. It has become a useful practice for the AC to start its first meeting of the year with an informal half-day retreat for its members. This facilitates the seamless integration of new members, contributes to building a common understanding among members of the new tasks

arising from the preceding session of the COP, and enhances the overall performance and effectiveness of the AC in the rest of the year.

17. At their 2018 retreat, AC members agreed:

(a) To assume a leadership role and be willing to take risks;

(b) To be more collaborative and build strategic alliances so as to engage other stakeholders in the work of the AC;

(c) To be more visible and to enhance outreach, including by being clear on the target audiences of its outreach materials and considering producing them in languages other than English.

18. Furthermore, the AC has developed a working routine of regularly seeking valuable inputs from experts, including from partner organizations of the Nairobi work programme on impacts, vulnerability and adaptation to climate change (NWP), representatives of other institutional arrangements established under the Convention and other relevant stakeholders with specific expertise.

19. In this context, the AC has promoted active observer participation in its meetings. Observer engagement and the potential for additional experience and expertise to inform its discussions were deemed to be beneficial to the work of the AC, including in pursuing its objectives of creating synergy and maintaining transparency.

## III. Conclusion of the implementation of the 2016–2018 workplan of the Adaptation Committee

20. At AC 8, in 2015, the AC agreed on its workplan for 2016–2018,<sup>11</sup> with the understanding that the workplan would remain flexible enough to incorporate any relevant outcomes arising from COP 21. COP 21 welcomed the workplan and requested the AC to carry out further tasks in preparation for the first session of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement and to support enhanced action prior to 2020.<sup>12</sup> Table 1 presents the workplan activities and outputs of the AC during the reporting period and indicates where further details are contained in this report.

### A. Overarching coherence

21. As part of its efforts to promote the implementation of adaptation action under the Convention in a coherent manner in line with the Cancun Adaptation Framework and the Paris Agreement, the AC, in line with its workplan, requested the secretariat to prepare an updated map of mandates, workplans and decisions with adaptation relevance under the Convention after each session of the COP.

22. The document prepared after COP  $23^{13}$  provided an overview of new developments relevant to adaptation under the Convention, including those necessitating action by the AC and those that the AC may wish to monitor. The AC took note of and agreed to draw on that information, as appropriate, in discussing subsequent items on its agenda and implementing its workplan activities.

23. The AC has continued its collaboration with other constituted bodies and institutional arrangements under the Convention, including the LEG, the NWP, the Technology Executive Committee (TEC), the Standing Committee on Finance (SCF), the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts, the Adaptation Fund, the GCF, the Climate Technology Centre and Network (CTCN) and the Paris Committee on Capacity-building (PCCB).

24. Its collaboration has developed over time in response to mandates from the COP and invitations from other institutional arrangements under the Convention seeking to enhance coherence and reduce duplication of efforts. The AC has also established linkages with other constituted bodies under the Convention, such as through the following groups, which were initiated by either the AC or one of the bodies and are fully operational and have produced concrete outcomes:

- (a) The AC NAP task force;
- (b) The AC working group on TEP-A;
- (c) The LEG support group for NAP Central;
- (d) The LEG NAP Expo advisory group;

(e) The Task Force on Displacement of the Executive Committee of the Warsaw International Mechanism;

- (f) The TEC task force on adaptation;
- (g) The Advisory Board of the CTCN;
- (h) The PCCB.

25. The AC has continued its efforts to improve coherence by exploring informal ways of exchanging information on current and future work of relevant entities and upcoming opportunities for collaboration. This has included holding informal bilateral meetings on the margins of COP 23 and the first part of the forty-eighth sessions of the subsidiary bodies with the high-level champions, the LEG and the SCF, and the facilitators of agenda items 4 (on the adaptation communication) and 6 (on the global stocktake) of the Ad Hoc Working Group on the Paris Agreement. Similar meetings are planned for COP 24, including in relation to TEP-A and the gender dialogue.<sup>14</sup> The AC has found holding joint meetings with other bodies to be very useful for ensuring coherent action on adaptation and wishes to pursue similar meetings in the future, including with the SCF.

26. The AC welcomes the continued provision of information to it by NWP partner organizations, which has contributed to the work of the AC over time. SBSTA 48.1 invited the AC to facilitate collaboration with a view to providing advice on the delivery of NWP mandates that relate to the work programmes of constituted bodies, and on opportunities to align efforts with relevant bodies, workstreams and institutional arrangements.<sup>15</sup> That invitation is reflected in the flexible workplan of the AC for 2019–2021 (see the annex).

27. The AC contributed to various in-session events at COP 23 and the first part of the forty-eighth sessions of the subsidiary bodies, including:

- (a) Informal consultations on NAPs;
- (b) The  $2^{nd}$  meeting of the PCCB;
- (c) The constituted bodies' dialogue on the integration of gender considerations;

(d) The tenth meeting of the research dialogue and an informal meeting with the research community;

- (e) NWP informal consultations;
- (f) The 11<sup>th</sup> NWP Focal Point Forum.

28. In response to decision 1/CP.23, paragraph 17(a) and annex II, the AC provided inputs to the Talanoa Dialogue<sup>16</sup> and to the stocktake on pre-2020 implementation and ambition to take place at COP 24.<sup>17</sup>

29. Finally, in response to the gender action plan adopted at COP 23,<sup>18</sup> the AC considered mainstreaming a gender perspective in its work. The AC welcomed the presentations on gender made by representatives of the secretariat and the women and gender constituency at AC 14 and took gender into consideration in developing its flexible workplan for 2019–2021.

### B. Provision of technical support and guidance to the Parties

30. The AC has made progress in providing technical support and guidance to the Parties in relation to adaptation action and means of implementation (finance, technology and capacity-building). The main focus of the AC in this regard is on providing technical support and guidance on NAPs, in close collaboration with the LEG and supported by the AC NAP task force.

31. The NAP task force reported on its activities at AC 13 and 14. In particular, it provided input to the development of NAP Central into a 'one-stop hub' of information, resources and data on the process to formulate and implement NAPs. It also contributed to the work of the NAP Expo advisory group and provided input to the 2018 NAP Expo,<sup>19</sup> held from 4 to 6 April 2018 in Sharm El Sheikh, including organizing a session on the monitoring and evaluation of adaptation. Finally, the task force participated in the expert meeting to assess progress in the process to formulate and implement NAPs referred to in paragraph 7 above.

32. AC 14 requested the NAP task force to develop intersessionally its draft workplan for 2019–2021 for consideration at AC 15, including consideration of ways to assist with the implementation of NAPs.<sup>20</sup>

#### 1. Adaptation action

33. During the reporting period the AC considered long-term adaptation planning, various approaches to adaptation, national adaptation goals and indicators, and partnerships providing technical support for adaptation.

34. AC 13 and 14 considered revised versions of the technical papers on long-term adaptation planning and various approaches to adaptation. The AC agreed to publish a relevant user-friendly online knowledge product and to disseminate it widely.

35. The expert meeting, referred to in paragraph 6(c) above, on national adaptation goals and indicators and how they relate to indicators for the SDGs and disaster risk reduction in the context of the Sendai Framework<sup>21</sup> had two objectives:

(a) To facilitate an exchange of views on national adaptation goals and indicators and related data collection, monitoring and evaluation and reporting frameworks;

(b) To inform Parties of what is possible in terms of national adaptation goals and indicators and how such goals and indicators relate to the global goal on adaptation.

36. Given those objectives, the growing recognition of the close relationship between the three global agendas – the Paris Agreement, the SDGs and the Sendai Framework – and the co-benefits of assessing adaptation progress, the expert meeting was designed to provide technical support and guidance to Parties on monitoring and evaluating adaptation action and mobilizing knowledge and experience in the context of relevant international frameworks for national adaptation planning and implementation.

37. AC 14 considered the report on the expert meeting<sup>22</sup> and agreed to forward relevant recommendations for consideration at COP 24 (see para. 58(i) below).

38. AC 12 considered the overview of the landscape of existing platforms providing technical support to developing country Parties on adaptation and an analysis of the information contained therein.<sup>23</sup> It requested the secretariat to make the analysis and the overview available on the adaptation knowledge portal,<sup>24</sup> if possible in a user-friendly format, and to provide feedback at AC 13, including usage statistics. It invited the administrators of other platforms that meet the established criteria to contact the secretariat for the platforms to be included in the overview and also invited organizations already listed in the overview to regularly update their information. It also requested the secretariat, NWP partner organizations and the CTCN to widely promote the overview.

#### 2. Means of implementation

39. One of the objectives of the AC is to provide guidance on ways to enhance financial, technological and capacity-building support, in particular related to access, institutional arrangements and enabling environments, including for the process to formulate and implement NAPs. The AC undertook various related activities throughout 2018, including

collaborating with the GCF on access to adaptation finance and fostering private sector engagement in adaptation.

40. Collaboration with the GCF included:

(a) Participation in the second annual meeting of the GCF Board with constituted bodies under the Convention, held during COP 23 on 15 November 2017;

(b) Participation of AC members in the GCF technical expert workshop on climate adaptation finance, held on 5 and 6 March 2018 in Songdo, Incheon, Republic of Korea.

41. SBI 47 welcomed the work of the AC on its information paper<sup>25</sup> on the experience of countries in accessing the GCF Readiness and Preparatory Support Programme for adaptation, including for the process to formulate and implement NAPs, and noted that it would inform the relevant AC workshop with a view to contributing to the assessment of progress in the process to formulate and implement NAPs.<sup>26</sup>

42. The aforementioned workshop took place on 6 April 2018 on the margins of the 2018 NAP Expo in Sharm El Sheik and addressed experience and lessons learned in relation to direct access accreditation and accessing the GCF Readiness Programme. It concluded with a discussion on how to enhance access to the GCF Readiness Programme and increase the number of direct access entities.<sup>27</sup> The report<sup>28</sup> on the workshop was considered at SBI 48.1 in the assessment of progress on NAPs and recommendations were forwarded for consideration by the SCF in the context of providing guidance to the operating entities of the Financial Mechanism.

43. The AC, together with the International Trade Centre, held a workshop on fostering private sector engagement in building resilience to climate change from 29 to 31 October 2018 in Geneva.

44. In plenary sessions, mini workshops and open labs,<sup>29</sup> the workshop covered:

(a) Assessing climate risks and preparing adaptation strategies;

(b) Implementing adaptation strategies, with a focus on small and medium-sized enterprises, by means of finance, technology, public–private partnerships and capacity-building;

(c) Designing policies and incentives for private sector investment in adaptation, including for formulating and implementing NAPs and nationally determined contributions under the Paris Agreement.

### C. Awareness-raising, outreach and sharing of information

45. As per its workplan, the AC agreed to hold an Adaptation Forum in synergy or conjunction with an annual high-level event. At AC 12 it was agreed to conduct a session at the 2018 Adaptation Futures conference, held from 18 to 21 June 2018 in Cape Town.<sup>30</sup> The 2018 Adaptation Forum, which took place on 19 June 2018, focused on ways to integrate climate change adaptation with the SDGs and the Sendai Framework.<sup>31</sup>

46. The AC has continued to prepare its regular Adaptation Finance Bulletin in collaboration with the Adaptation Fund, the GCF, the Global Environment Facility, the LEG

and the SCF<sup>32</sup> to inform a broad range of stakeholders on recent developments in the context of international adaptation finance.

47. All information products of the AC are disseminated broadly, including through the adaptation knowledge portal and on a dedicated Facebook page, "The Adaptation Exchange",<sup>33</sup> which is maintained by the secretariat's Adaptation programme. As at 22 November 2018, the Exchange had 14,953 followers.

### D. Technical examination process on adaptation

48. TEP-A was established in decision 1/CP.21 as part of enhancing action prior to 2020, to be organized by the subsidiary bodies, conducted by the AC and supported by the secretariat. It includes annual technical expert meetings on adaptation (TEM-A), bringing together a broad group of stakeholders to discuss policies, action, concrete opportunities and implementation.

49. Led by the International Federation of Red Cross and Red Crescent Societies, Business for Social Responsibility, the United Nations Environment Programme, the CTCN and the GCF, the 2018 TEM-A explored opportunities and options for adaptation planning in relation to vulnerable groups, communities and ecosystems.<sup>34</sup> They followed an interactive approach that included panel discussions, PowerPoint presentations and engaging the audience via an interactive audience management tool that enabled real-time submission of questions and comments via mobile devices.

50. The discussions held at the 2018 TEM-A as well as other information relevant to the topic are reflected in a technical paper prepared by the secretariat in consultation with the AC.<sup>35</sup>

51. The 2019 TEP-A will focus on adaptation finance, including the private sector. AC 14 requested the TEP-A working group and the secretariat to produce a concept note for discussion by early January 2019, to develop a prioritized list of topics for the final 2020 TEP-A and to report back at AC 15 on progress.

52. COP 23 invited Parties and non-Party stakeholders to organize regional TEMs, building on existing regional climate action events, as appropriate, with a view to examining specific finance, technology and capacity-building resources necessary to scale up action in regional contexts, including through regional mitigation and adaptation initiatives, and to provide reports thereon to the secretariat as input to the TEPs.<sup>36</sup>

53. In response, six regional TEM-As took place in 2018 (see table 2), many of which the AC was invited to and participated in (AC members participated as moderators and presenters).<sup>37</sup>

54. In general, the participants noted that further regional TEM-As would benefit the regions. They emphasized the need for enhanced regional collaboration and for a dedicated space for sharing knowledge and identifying opportunities. They welcomed the meetings' innovative design and the collaboration between Parties and non-Party stakeholders, and emphasized that such meetings should continue to be a vehicle for different actors to share knowledge and mobilize adaptation action at the national, subnational, local and individual level.

## IV. Future workplan of the Adaptation Committee

55. AC 13 initiated consideration of the flexible workplan of the AC for 2019–2021<sup>38</sup> and AC 14 finalized it. The AC agreed that its work should be ambitious, strategic, inspiring and results driven, with the AC striving to become a recognized interface between science, policy and practice. The AC also agreed to strengthen its ability to enhance access to relevant information and knowledge, to promote synergy and address barriers, and to facilitate linkages between stakeholders to foster the sharing of new insights, experience and lessons learned. The AC further agreed to remain flexible in order to take on new and emerging tasks, including those resulting from future agreements and decisions under the Convention, such as from COP 24.

56. In considering its future activities, the AC took into account relevant mandates and invitations from the SBSTA and the SBI as well as the invitation contained in the workplan of the Executive Committee of the Warsaw International Mechanism for it to consider making efforts, in undertaking its work, to reduce and avert loss and damage among particularly vulnerable developing countries, vulnerable populations and the ecosystems that they depend on and to share the outcomes with the Executive Committee.

57. The agreed flexible workplan of the AC for 2019–2021 is contained in the annex.

## V. Recommendations to the Conference of the Parties

58. On the basis of its 2018 activities, including the 2018 TEP-A, the AC agreed to forward the following recommendations for consideration at COP 24. The COP may wish to:

(a) Encourage Parties to strengthen adaptation planning, including by engaging in the process to formulate and implement NAPs, taking into account linkages with the SDGs and possible co-benefits between mitigation and adaptation, and by mainstreaming adaptation in development planning;

(b) Urge Parties and non-Party stakeholders to mainstream gender considerations in all stages of their adaptation planning processes, including NAPs and the implementation of adaptation action, taking into account available guidance;<sup>39</sup>

(c) Encourage Parties to apply a participatory approach to adaptation planning and implementation so as to make use of stakeholder input, including from the private sector, civil society, indigenous peoples, local communities, migrants, children and youth, persons with disabilities and people in vulnerable situations in general;

(d) Encourage Parties to take an iterative approach to adaptation planning, implementation and investment, with the long-term goal of transformational change, to ensure that adaptation is flexible, robust and not maladaptive and to allow for the integration, at least periodically, of the best available science;

(e) Encourage Parties to take into consideration and utilize, as appropriate, various approaches to adaptation planning, including community-based adaptation, ecosystem-based adaptation, livelihood and economic diversification and risk-based approaches, and to ensure that such approaches are not mutually exclusive, but rather complementary, allowing for synergy in enhancing resilience;

(f) Invite relevant institutions under the Convention and non-Party stakeholders to strengthen support (financial, technical, technological and capacity-building) for adaptation planning, including for collecting climate data and information, noting the urgent need for adaptation action to address current and short- and long-term risks of climate change;

 (g) Invite Parties and interested organizations to share case studies of initiatives that focus on ecosystems and adaptation planning for vulnerable communities and groups as agents of change;

(h) Request the NWP to collect the case studies referred to in paragraph 58(g) above and disseminate them on the adaptation knowledge portal with a view to enhancing the translation of knowledge into practice;

(i) Invite Parties and relevant entities working on national adaptation goals and indicators to strengthen linkages with the SDGs and the Sendai Framework monitoring systems, taking into account:

(i) The importance of designing adaptation monitoring and evaluation systems according to a country's overall objectives for adaptation, and considering the benefits and drawbacks of quantitative and qualitative indicators when developing methodologies;

(ii) That although full and complete harmonization of the three global agendas may not be feasible or useful, some degree of synergy could be beneficial;

(iii) That enhancing individual and institutional technical capacity for data collection and assessment of adaptation is an ongoing task for many countries. Increased capacity could help to link data gathering and reporting systems for the three global agendas at the national level;

(iv) That improved coordination results in a reduced reporting burden for countries and enhanced cost-effectiveness of measures that cut across the three agendas;

(v) That subnational monitoring and evaluation programmes should be linked with national-level monitoring and evaluation systems to provide a complete picture on adaptation;

 (j) Express its appreciation to Parties and organizations that organized regional TEM-As in 2018;

(k) Encourage Parties and organizations to build on the outcomes of the 2018 regional TEM-As when planning and implementing adaptation and to continue organizing such meetings in 2019 with a view to enhancing adaptation action and its overall coherence.
