Article 6.4 Supervisory Body – Sixteenth meeting Bonn, Germany, 12 to 16 May 2025

Background

- Nov. 2021: 3/CMA.3, paragraph 5(h) requested the SBM to consider opportunities to engage with the Local Communities and Indigenous Peoples Platform and its Facilitative Working Group.
- Jul. 2023: SBM006 considered concept note "Engagement with the Local Communities and Indigenous Peoples Platform (LCIPP) and its Facilitative Working Group (FWG)" and requested the secretariat to (a) Extend an expression of interest to the FWG to discuss possible future collaboration; (b) Launch a call for public inputs on how the Article 6.4 mechanism could consider matters related to indigenous Peoples and local communities; and (c) Organize a dedicated webinar to consider these matters.
- Oct. to Nov. 2023: Call for inputs- Meaningful engagement of Indigenous Peoples and local communities in Article 6.4 mechanism, for instance, on (1) What are the current or anticipated challenges Indigenous Peoples and local communities face in engaging with the Article 6.4 mechanism?, (2) What mode of communication could facilitate better dialogue between the Supervisory Body and Indigenous communities? and (3) How would you envision meaningful long-term engagement and active participation from Indigenous Peoples and local communities on the work of the Supervisory Body and the mechanism? Received inputs are 14.

- Nov. 2023: SBM sent an expression of interest letter to express its interest in discussing and exploring collaborative opportunities with the LCIPP and FWG in areas of common interest.
- Apr./May. 2024: SBM 011 took note of the engagement with Local Communities and Indigenous Peoples Platform (LCIPP) and its Facilitative Working Group (FWG) and with the wider local communities and Indigenous Peoples stakeholders, and of the planned engagement, in particular the meeting between the Chair and Vice-Chair of the SBM and the co-chairs of the FWG of the LICPP and a webinar planned with wider local communities and Indigenous Peoples stakeholders prior to the thirteenth meeting. The SBM agreed to consider this matter at a future meeting, including the possibility to hold an interaction with local communities and Indigenous Peoples at CMA 6.
- Nov. 2025: -/CMA.6, paragraph 2 requested the SBM to engage, in consultation with interested stakeholders, further independent scientific and technical expertise and local communities, and include the knowledge, sciences and practices of Indigenous Peoples, as relevant, to support its work, including through its expert panels, to review proposals as necessary and receive independent scientific and technical advice.
