### **UN4NAPs**

- UN-wide rapid technical backstopping initiative for National Adaptation Plans (NAPs), launched in 2021 by the UNFCCC secretariat, in response to mandates for engaging international organizations in support of climate change adaptation, to scale up technical support to LDCs and SIDS to formulate and implement NAPs.
- The partnership enables the UN-wide system of organizations and other intergovernmental organizations to respond to technical requests identified by any country that is in the process of formulating or implementing its NAP.
- When receiving requests for technical assistance, the UNFCCC secretariat communicates with relevant partners from a roster of more than 50 organizations for a prompt response.
- UN4NAPs will continue to facilitate support for countries in their efforts towards NAP formulation and implementation, through a collaborative, cross-organizational approach; thus, contributing towards the fulfilment of the GGA and GST decisions, for countries to have formulated a NAP by 2025 (GST), and to be implementing the NAP by 2030 (GST/GGA).



## UN4NAPs: Categories of technical assistance that can be catalyzed between agencies and countries



Simple technical queries which can be answered by relevant agencies via email;



Delivery of specific data/knowledge products (such as datasets, analytical tools, guidance material);




Longer-term capacity development/engagement with the requesting country;



Review of draft NAPs upon request by a country, based on agencies' area of expertise, with a view to enhance the coverage of issues to facilitate subsequent implementation.

More than 150 requests for technical assistance, submitted by more than 30 countries





### Process to request technical assistance through UN4NAPs

UN4NAPs focal points in Governments, in coordination with NFP, submit requests for technical assistance or queries, related to their NAP, via email to un4naps@unfccc.int


UNFCCC follows up with the country to clarify details on the exact needs

UNFCCC shares the request(s) with relevant partner organizati on(s)

Partner organizati on(s) respond(s) promptly

UNFCCC organizes initial meetings between country and organization(s) to ensure the implementation of the needed response

# Areas related to NAP formulation under which requests have been received

- Technical review of draft NAPs or adaptation strategies;
- Strengthening capacities in climate observation and modeling, and access to climate scenarios;
- Improving knowledge in biodiversity assessments and conservation measures for biodiversity, water and soil;
- Developing nature-based solution strategies;
- Technical assistance to strengthen efforts of accessing climate finance;
- Strengthening monitoring and evaluation as well as information management systems.



## **Examples of contributions to technical assistance facilitated through UN4NAPs (by UNU)**

- Request of Government: Review of draft NAP of Zimbabwe (March 2023). The UNFCCC secretariat consolidated the inputs by WHO; UNDRR; WFP; UNHCR; WMO; the Commonwealth Secretariat; CGIAR; OHCHR; UN Habitat, the Adaptation Fund, UNDP and UNU, and shared with Government of Zimbabwe for their consideration.
- UN4NAPs facilitated initial discussions with several countries and UNU on provision of support and capacity building on vulnerability assessments and the deployment of the Economics of Climate Adaptation (ECA) tool.
