- 2. Providing basis for SBSTA 58 to reflect on the findings from the workshop captured by the technical paper and, where appropriate, make recommendations to inform the preparation of a manual by the secretariat containing illustrative elements of information for the initial report, noting that the illustrative elements of information to be included in the manual have no formal status, are for voluntary use and shall not be used or referred to in the Article 6 technical expert review;
- 3. Identifying capacity-building needs.
