Initial considerations on the next flexible workplan of the Adaptation Committee for the years 2025-2027

Recommended action by the Adaptation Committee

The Adaptation Committee (AC), at its 25th meeting, will be invited to consider the information contained in this document and agree on inter-sessional work to establish a draft flexible workplan for consideration and agreement at AC 26 (September 2024).

1. Introduction and background

- 1. By decision 2/CP.17, the Conference of the Parties (COP) requested the AC to develop a three-year plan for its work, in accordance with its agreed functions. Since then, the AC has kept up the practice of using three-year plans to guide its work. The fourth workplan was agreed at the AC's 20th meeting, covering the years 2022 to 2024. The AC has been keeping its workplans flexible to take on new and emerging tasks and allow for flexibility regarding the timing of activities and revisions of the workplan, as needed.
- 2. As the current workplan concludes at the end of 2024, the AC, at its 25^{th} meeting, will initiate the elaboration of a new workplan to be agreed in the 2^{nd} half of 2024. This document contains possible guiding principles, priority themes and next steps to support the AC in the elaboration of its next workplan.

2. Indicative priorities and guiding principles

- 3. The AC may wish to consider the following guiding principles for the elaboration of its next workplan:
 - a) The AC's mandate and objectives, as laid out in decision 1/CP.16, para. 20, which established the AC to promote the implementation of enhanced action on adaptation in a coherent manner under the Convention (see annex 1);
 - b) The principles guiding adaptation action as contained in Article 7.5 of the Paris Agreement (adaptation action should follow a country-driven, gender-responsive, participatory and fully transparent approach, taking into consideration vulnerable groups, communities and ecosystems, and should be based on and guided by the best available science and, as appropriate, traditional knowledge, knowledge of indigenous peoples and local knowledge systems, with a view to integrating adaptation into relevant socioeconomic and environmental policies and actions, where appropriate);
 - c) The overall aim of contributing to the Global Stocktake (GST), and the implementation of the UAE Framework for Global Climate Resilience as adopted in decision 2/CMA.5 with the purpose of guiding the achievement of the global goal on adaptation (GGA) and the review of overall progress in achieving it;
 - d) A critical self-assessment of past achievements as well as current and future challenges in relation to its mandates;
 - e) The principle of flexibility that the AC has been applying to its workplans to allow for adjustments to accommodate new mandates and developments.

3. Content

- 4. Ongoing activities will be included in the next workplan, including the mandates received from the COP, the Conference of the Parties serving as the Meeting of the Parties to the Paris Agreement (CMA), and the Subsidiary Bodies, in particular related to the Global Stocktake, the GGA and supporting countries in formulating and implementing National Adaptation Plans (NAPs).
- 5. Further, the AC may wish to agree on a limited number of thematic activities consistent with the guiding principles above, with the goal of maximizing impact and avoiding proliferation. In this, the AC may wish to consider which of its recent thematic work areas it wishes to further explore, and how and with whom these activities could be carried out. See annex 2, table: Thematic work by the AC to be included in its workplan for 2024-2027.

4. Structure

- 6. The AC has over time used various approaches to structure its workplans. While the initial workplan for the years 2013-2015 was simply structured into three workstreams (technical support and guidance to the Parties on adaptation action; on means of implementation; and awareness-raising, outreach and sharing of information), these workstreams have varied over time, expanded into more detail, and then most recently reduced again to the three main clusters applied in the current workplan for 2022-2024:
 - Workstream 1: Promoting collaboration with the constituted bodies, partner organizations of the Nairobi work programme, and others
 - Workstream 2: Providing technical support and guidance: Adaptation planning and implementation, including means of implementation, at the national and subnational level, and reviewing subnational, national and overall adaptation progress
 - Workstream 3: Information sharing, awareness-raising and outreach
- 7. The AC may wish to decide whether it wishes to continuing structuring its workplan along the current workstreams, or whether the structure requires any revisions.

5. Possible next steps

- 8. The AC may wish to consider the following suite of steps to arrive at the adoption of its next workplan at AC 26 (September 2024):
 - a) AC 25: Initial discussion, including a self-assessment, as appropriate, on priority areas of work for the years 2025-2027; as well as on a possible revision of the structure of the workplan (see annex 2);
 - b) April 2024:
 - i) Co-Chairs, interested AC members and the secretariat perform a screening of the priority areas discussed, and elaborate a first set of possible activities to address these areas, in alignment with mandated activities;
 - ii) AC to issue a call for inputs, through NGO focal points, Adaptation Contact Points, and from other constituted bodies, to solicit inputs from stakeholders;
 - c) May 2024: 1st conference call with interested AC members to discuss a first order draft of the work plan;
 - d) End of June 2024: 2nd conference call with interested AC members to discuss a second order draft of the work plan;
 - e) AC 26 (10-13 September 2024): Approval of the work plan for inclusion in the 2024 annual report of the AC
 - f) AC 27 (early 2025): Review of the workplan in line with the outcomes of COP 29.

Annex 1

Mandated objective and functions of the AC

In the consideration of its forthcoming workplan the AC may want to recall the objective and functions of the AC which are stipulated by decision 1/CP.16.

The overall obective of the AC is to promote the implementation of enhanced action on adaptation in a coherent manner under the Convention, through its five functions:

- a) Providing technical support and guidance to the Parties, respecting the country-driven approach, with a view to facilitating the implementation of adaptation activities;
- b) Strengthening, consolidating and enhancing the sharing of relevant information, knowledge, experience and good practices, at the local, national, regional and international levels, taking into account, as appropriate, traditional knowledge and practices;
- c) Promoting synergy and strengthening engagement with national, regional and international organizations, centres and networks, in order to enhance the implementation of adaptation actions, in particular in developing country Parties;
- d) Providing information and recommendations, drawing on adaptation good practices, for consideration by the Conference of the Parties when providing guidance on means to incentivize the implementation of adaptation actions, including finance, technology and capacity-building and other ways to enable climate-resilient development and reduce vulnerability, including to the operating entities of the financial mechanism of the Convention, as appropriate;
- e) Considering information communicated by Parties on their monitoring and review of adaptation actions, support provided and received, possible needs and gaps and other relevant information, including information communicated under the Convention, with a view to recommending what further actions may be required, as appropriate.
