Status Overview of the Adaptation Committee's Communication and Outreach Information Note

Recommended action by the Adaptation Committee

This paper provides an update on the work undertaken so far to operationalize the Adaptation Committee's communications strategy for 2024-2025, as introduced during AC 25.

The Adaptation Committee will be invited to consider the information contained in this note with a view to providing further guidance on the implementation of the communications plan and strategy for the period 2024-2025.

1. Background

1. The Adaptation Committee (AC) took note of the document on the communications strategy $2024-2025^1$ at its 25^{th} meeting (AC 25) based on the lessons learned from the 2022-2023 communication plan and strategy.²

- 2. The AC decided for the communications working group to continue discussions intersessionally on communications activities, including how to further disseminate information, as well as the proposal of a new feedback surveys on virtual and in-person events and publications.
- 3. The AC agreed to consider how to incorporate strategic communications in its next flexible workplan for 2025-2027.

2. Objectives

- 4. The AC's two overall key areas of improvement for communication in 2024-2025 are:
 - a) increasing the reach and impact of the AC's events and publications; and
 - b) increasing the visibility and engagement of the AC overall.
- 5. These areas of improvement are linked to the following objectives as established in the communication plan and strategy for 2022-2023:
 - a) Raise the profile of adaptation within and outside of the UNFCCC process;
 - b) Strategically enhance the visibility of the AC as the primary body on providing coherence in adaptation in the UNFCCC process;
 - c) Enhance the profile of the AC as a recognized body for adaptation for Parties and non-Party stakeholders, as well as the UN System;
 - d) Improve understanding of the nature and value of the AC's work, and its role in enhancing effective international adaptation action;
 - e) Increase reach and usage of AC resources, including reports, papers, and other knowledge products and events;
 - f) Enhance the attention and thus (virtual) participation in AC events;
 - g) Strengthen existing partnerships, and build new ones, with other bodies under the UNFCCC process and external organizations working on adaptation.

3. Update on communications activities for 2024-2025

6. The implementation of the AC communications strategy 2024-2025 has primarily focused on content development and expanding outreach by disseminating AC publications through delivery channels. The AC

communications strategy 2024-2025 was built on four pillars, aligned with its mission statement³, following the 2022-2023 communication plan:

- a) Foundational items and processes,
- b) Content development,
- c) Delivery platforms, and
- d) Monitoring and evaluation, to ensure that communication content development, distribution and learning are purposeful, impactful, and well-managed under time and resource constraints.
- 7. The section below outlines the continued and new action items for the secretariat under each pillar of the 2024-2025 communication strategy.

a) Foundational items and processes

- 8. Foundational elements are items that link back to cross-cutting issues that create a better enabling environment for communications purposes, development, delivery, and learning. To mainstream the foundational items and processes, the secretariat will
 - a) Further scrutinize the insights from the audience assessment survey⁴ to inform the AC communications strategy 2025-2026.
 - b) Continue efforts to strengthen direct communication with various constituencies in the adaptation community. Additionally, two-way communication with the Adaptation Working Group of YOUNGO is ongoing.

b) Content development

9. This step involves the ideation, drafting, editing and review of content to be distributed. Action items which are continued from the 2024-2025 communication strategy include:

- a) Development of interactive elements and visuals for public-facing outputs is continued through coordination with the current design firm for forthcoming AC publications, and the interactive portal⁵ on the State of Adaptation Action by Parties is also being launched by the AC in COP29.
- b) At AC 25, the AC requested the secretariat to prepare a list of AC publications to be translated into different UN languages for the AC to prioritize intersessionally. The proposed options for AC to consider for future translation work are:
 - i) Thirty years of Adaptation Under the UNFCCC: From the Convention to the Paris Agreement and beyond (forthcoming) and
 - ii) Policy brief on progress, good practices and lessons learned, challenges and opportunities in the application of traditional knowledge, knowledge of Indigenous Peoples and local knowledge systems in adaptation(forthcoming).

iii) Navigating the landscape of support for the process to formulate and implement national adaptation plans⁶.

- 10. Following the AC agreement on the list, the publications will be translated into additional UN official languages, using automated machine translation tools. A disclaimer will be included to caution against possible inaccuracies inherent in automated translations.
- 11. Issue 17 of the Adaptation Finance Bulletin⁷ has been published. The bulletin informs a broad range of stakeholders about recent developments in the international adaptation finance arena by showcasing updates from climate funds, constituted bodies and other relevant organizations, as well as outcomes from negotiations under the COP, CMA, and the SBs. A decision is pending by the AC to decide on whether to continue the Adaptation Finance Bulletin as it is or to expand it into an Adaptation Action and Finance Bulletin. Conversations at AC 25 indicated a preference to maintain the Adaptation Finance Bulletin in its current state and potentially add a second publication. The AC may wish to consider combining the new bulletin with the periodic updates the secretariat shares with Adaptation Contact points. (The AC provides Adaptation Contact points with information on upcoming activities and new publications by the AC and other constituted bodies, twice a year, before the sessions of the subsidiary bodies).
- 12. The webpage for the new publication, "Toolkit for Monitoring, Evaluation, and Learning for National Adaptation Plan Processes", produced by the AC in collaboration with the NAP Global Network, has been updated for easier access.

c) Delivery Platforms

- 13. The AC is distributing its content through several channels to increase the number and expand the range and size of audience(s). The action items under the 2024-2025 communication strategy that are being continued, along with new action items, are outlined below:
 - a) AC publications are being systematically distributed through the platforms PreventionWeb⁹, weADAPT¹⁰ and Climate Adaptation Knowledge Exchange (CAKE)¹¹ to increase their visibility. In terms of social media, efforts are currently underway to explore alternative social media platforms beyond Facebook and Twitter. Distribution is also being strengthened through arrangements with YOUNGO.
 - b) **(New)** A collaboration with United Nations iLibrary¹² has been established for dissemination of AC publications. The UN iLibrary is the comprehensive global search, discovery, and viewing source for digital content created by the United Nations.

d) Monitoring & Evaluation:

14. This step feeds into all steps in the above communication cycle, involving the analysis of the level of impact of various communications outputs. It also presents opportunities to improve communication in an iterative and adaptable manner. Action items from 2024-2025 communication strategy that are continued are stated below:

a) Iterative monitoring and evaluation of AC communications efforts continue. Evaluation of the AC's communication efforts is being conducted quantitatively by the secretariat before each AC meeting, utilizing KPIs and data monitoring services to assist in understanding the impact of AC communication efforts through various delivery channels. The results are listed in section 3.1 below.

b) To ensure audience feedback on AC products, feedback surveys on virtual and in-person events, as well as on publications, are being disseminated to capture qualitative data on audience experience and content relevance. During the current reporting period, no additional survey responses have been received from the publication pages.

3.1 Evaluation of communication efforts since AC 25

15. In the current reporting period, between 1 March 2024 and 15 August 2024, the AC communication efforts have yielded the following results (these are compared against the results of previous reporting period 1 September 2023 - 29 February 2024):

a) Adaptation LinkedIn¹³:

16. In the current reporting period, the Adaptation LinkedIn group has expanded to 2,562 members, an increase from 2,000 members as of 28 February 2024. Despite this growth, active membership has declined to 10,461 from 25,000 in the previous period. Active members are those who have either visited the group or viewed its posts on the LinkedIn home feed during a specific timeframe. The group recently added 41 new posts, garnering a total of 32,763 views (a decrease from 158 posts with a total of 87800 post views in the previous reporting period). This averages to approximately 799 views per post, an increase from the previous average of 556 views per post. However, engagement has decreased, with the posts collectively receiving only 2 comments and 448 reactions, compared to 76 comments and 1,256 reactions previously. **The top performing posts** on LinkedIn were related to SB 60 side events of AC and other constituted bodies.

b) Adaptation X¹⁴:

17. The Adaptation Exchange X feed has a total of 4,935 followers, compared to approximately 4,776 followers in February 2024. The number of posts in the current reporting period is 56, compared to 35 in the previous reporting period. These posts have generated around 12,145 impressions, compared to 7,227 impressions in the previous period. On average, posts in this period received about 216 impressions, a slight increase from the previous average of 207. **The top performing posts** on X included coverage of the expert dialogue on mountains and climate change at SB 60 and the inaugural meeting of the advisory board of the Santiago Network.

c) Adaptation Facebook¹⁵:

- 18. The Adaptation Exchange Facebook page now has 19,880 followers, an increase from 19,636 in the previous reporting period. The page attracted 407 new followers, fewer than the 459 new followers in the previous period. During this period, the page featured 12 posts, compared to 59 posts in the previous period. These posts generated about 3,605 impressions, a decrease from 24,000 in the previous period. There were 122 instances of content interaction, down from 459 previously. **The top performing posts** during this period focused on announcing new events and meetings organized by the AC and other constituted bodies.
- 19. At its 26th session, the Conference of the Parties¹⁶ welcomed the work of the AC in 2019, 2020 and 2021 and invited the AC to improve its efforts to measure the outreach of its events and publications by including,

in its flexible workplan, statistics – disaggregated by gender and region – on its awareness-raising, outreach and information-sharing efforts, such as events and publications. Below are data related to the regional and gender distribution of Facebook users that follow the Adaptation Exchange Facebook page, in the current reporting period (1 March 2024- 15 August 2024):

- a) Top ten **countries** following the Adaptation Exchange Facebook page: United States, India, Bangladesh, Mexico, United Kingdom, Germany, Canada, Kenya, Peru and Australia.
- b) The top three **age ranges** that follow the Adaptation Exchange Facebook are: 35-44-year-olds (36.9%), followed by 25-34-year-olds (29.4%), and 45-54-year-olds (17.1%).
- c) Regarding **gender distribution** among the Adaptation Exchange Facebook community, 57% identify as male, 43% as female, and less than 1% identify as other or did not specify.
- d) Adaptation Exchange posts are accessed from the following top ten **cities**: Dhaka (Bangladesh), Lima (Peru), Nairobi (Kenya), Kathmandu (Nepal), Phnom Penh (Cambodia), Mexico City (Mexico), Bangkok (Thailand), London (UK), Cairo (Egypt) and Delhi (India).

d) Adaptation Committee website¹⁷:

- 20. In the current reporting period (1 March 2024-15 August 2024), the main page of the AC website received 7,252 views. The publication pages of the AC website were visited 661 times, a decrease from 1,739 visits in the previous period. Total downloads for AC publications for the current period were 220 as compared to 631 downloads in the previous reporting period.
 - a) The most downloaded publications during this period were:
 - b) "Progress, good practices and lessons learned in prioritizing and incorporating gender-responsive adaptation action. Policy brief" 18 (29 downloads)
 - c) New 2024 publication, "Toolkit for Monitoring, Evaluation, and Learning for National Adaptation Plan Processes" (20 downloads)
- 21. The publication, "25 Years of Adaptation Under the UNFCCC"²⁰ and a 2020 publication, "Data for adaptation at different spatial and temporal scales²¹" were downloaded 12 times during the current reporting period.
- 22. The AC decision booklet that compiles all conclusions and decisions by the governing and subsidiary bodies that pertain directly to the AC has been updated on the website in August 2024.
- 23. The 17^{th} issue of the Adaptation Finance bulletin was published following AC 25 and distributed to approximately 4,269 subscribers. This issue achieved an open rate of 43% and a link click rate of 8%.

24. Since AC 25, the AC has been featured in two UNFCCC newsroom articles, one on an AC virtual dialogue to address developing countries' capacity gaps in accessing finance²², which has been viewed7,252 times, and another on the 2024 Adaptation Forum²³, which has 1,640 views. Updates on AC events and new publications are also shared with the Regional Collaboration Centres (RCCs) for coverage in their newsletters.

4. Next steps

- 25. The Adaptation Committee, at its 26th meeting, will be invited to:
 - a) Take note of the information contained in this report;
 - b) Consider how to incorporate strategic communications in its next flexible workplan for 2025-2027;
 - c) Confirm the AC publications suggested by the secretariat for translation into different UN languages, and the order in which they will be translated;
 - d) Consider the need for any new feedback surveys on virtual and in-person events and publications;
 - e) Decide on the new Adaptation Finance bulletin;
 - f) Provide guidance to the secretariat on how to better display information on the UNFCCC website, including the methodologies identified by the joint AC/LEG/SCF working group on adequacy and effectiveness of adaptation and support (see update under AC26 item 4).
