Cristina Rumbaitis del Rio, UN Foundation

Cristina Rumbaitis del Rio is a Senior Advisor on Adaptation and Resilience for the UN Foundation. She has over 20 years of experience designing and implementing climate change adaptation initiatives with organizations such as the Rockefeller Foundation, the World Resources Institute and the Global Commission on Adaptation, where she led development of impact initiatives on locally-led adaptation, agriculture, food security, among other issues. She was the Regional Programme manager for Action on Climate Today, a UK supported climate change program that mainstreamed resilience into planning and budgeting at the national and sub-national level in India, Pakistan, Nepal, Bangladesh, and Afghanistan. Cristina has a Doctorate in Ecology.



Timo Leiter, London School of Economics and Political Science

Dr Timo Leiter is a global thought leader on climate change adaptation and climate policy with over twelve years' experience in international development and academia. He is a Distinguished Policy Fellow at the London School of Economics and Political Science (LSE) and works at the intersection between research,

She oversees the work on metrics framework to track progress of adaptation solutions and increasing the resilience of people and nature, as well as the work on adaptation finance and business adaptation agenda.
