C. GOALS FOR THE SESSION

- Based on the mandate given by the APA Co-Chairs, the specific goals for APA agenda item 5 at this session are:

- First, identify the different options contained in the informal note in as clear and concise manner as possible, including how to provide flexibility to those developing countries that need it in the light of their capacities.
- Second, ensure that all elements in the CF informal note are clear and fully elaborated;
- Third, discuss the legal nature (i.e., the “shalls” and “should”) of the MPGs, consistent with paragraphs 7 to 12 of the Paris Agreement;
- Fourth, capture essential elements necessary to be included in the COP and CMA decisions that adopt the MPGs at COP 24;
- Fifth, further Parties’ understanding of relevant interlinkages with other Paris Agreement Work Program items; and
- Sixth, ensure a clear understanding of Parties’ views on, at minimum, the key issues, through sufficient time to exchange views.
