

## Section H: Facilitative, multilateral consideration of progress Format and steps (Section H.4)

- Format:
  - **Approach 1:** In-person during the SBI session. [H.4.1.]
  - **Approach 2:** Online conference. [H.4.2.]
- Steps:
  - **Approach 1:** Q&A phase, followed by presentation by Party, followed by discussion, followed by additional written responses by Party. Dedicated online platform. Secretariat to make arrangements. [H.4.3, H.4.4, H.4.5, H.4.10, H.4.11, H.4.12]
- Participation by the Party:
  - **Approach 1:** Each Party considered under FMCP [H.4.6]
  - **Approach 2:** Self determined by a Party [H.4.7.]
  - **Approach 3:** As a group of Parties [H.4.8.]
  - **Approach 4:** LDCs and SIDS undergo FMCP at discretion [H.4.8]
- Actors:
  - **Approach 1:** Parties. [H.4.9.a.]
  - **Approach 2:** Parties, relevant stakeholders, and registered Observers [H.4.9.b.]

# Timing (Section H.5)

## **Frequency of FMCP:**

- **Approach 1:** At regular intervals [H.5.2.a.]
  - Approach 1.1: Every 2 years. [H.5.2.e.]
  - Approach 1.2: Once in every two transparency reports. [H.5.2.f.]
  - Approach 1.3: FMCP for the progress every 2 years, FMCP of NDCs every 5 years. [H.5.2.g.]
- **Approach 2:** Linked with NDC cycle
  - Approach 2.1: Once for achievement of NDC, at the end of the NDC cycle. [H.5.2.b.]
  - Approach 2.2: At least once during NDC implementation. [H.5.2.c.]
  - Approach 2.3: Twice during each NDC implementation cycle. [H.5.2.d.]
- **Approach 3:** Self-determined
  - Approach 3.1: The frequency of FMCP is nationally determined by the participating Party. [H.5.1.]
  - Approach 3.2: Parties activate through a self-trigger. [H.5.2.h.]

## **Commencement of FMCP:**

- **Approach 1:** Linked to the submission of biennial transparency report
  - FMCP to start within 4/6/12 months after the submission of the transparency report. [H.5.3.]
- **Approach 2:** Linked to the completion of the TER
  - FMCP to start after completion of TER. [H.5.4.]
- **Approach 3:** Not linked with the completion of the TER
  - TER and FMCP conducted independently. FMCP starts before conclusion of TER. [H.5.5.]

## **Completion of FMCP:**

- **Approach 1:** Completed within 12 months of transparency report submission [H.5.6.a]
- **Approach 2:** Completed within 9 months of technical expert review report [H.5.6.b]
