[The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement,

Recalling decisions 1/CMP.3, 1/CMP.4 and 1/CMP.13,

Emphasizing the added value and comparative advantage of the Adaptation Fund in providing support to developing countries,

Noting the need to ensure the sustainability, adequacy and predictability of funding for the Adaptation Fund,

I. Governance

- 1. Decides that the Adaptation Fund shall serve the Paris Agreement under the [authority and] guidance of, and be accountable to, the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement with respect to all matters relating to the Paris Agreement effective 1 January 2019 [subject to the decision to be taken by the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol at its fifteenth session (November 2019), in accordance with decision 1/CMP.13, paragraph 13;]
- 2. Recommends that the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol [decide, at its fifteenth session,] that the Adaptation Fund shall exclusively serve the Paris Agreement effective [1 January][31 December] 2020;
- 3. *Invites* the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol to decide that the Adaptation Fund shall no longer serve the Kyoto Protocol as of the date specified in paragraph [2] above;
- 4. *Decides* that in accordance with paragraph [2] above, the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement will transmit guidance on matters relating to the Paris Agreement to the Adaptation Fund Board;
- 5. [*Invites* the Conference of the Parties to consider designating the Adaptation Fund as an operating entity of the Financial Mechanism of the Convention in accordance with Article 11 of the Convention;]

II. Composition of the Adaptation Fund Board

- 6. Decides that further to decision 1/CMP.3, paragraph 6, the Adaptation Fund Board shall comprise members and their alternates representing Parties to the Kyoto Protocol and Parties to the Paris Agreement;
- 7. [Also decides that the Board shall comprise X additional members and their alternates representing Parties that contribute to the Adaptation Fund;]

III. Operating modalities

- 8. Requests the Adaptation Fund Board to enhance complementarity and coordination with the entities entrusted with the operation of the Financial Mechanism and other funds, entities and channels of climate change financing outside the Adaptation Fund with a view to enhancing the support provided and mobilized to developing countries to implement the adaptation actions under the Paris Agreement.
- 9. Decides that, from 1 January 2019, developing country Parties to the Paris Agreement, especially those that are particularly vulnerable to the adverse effects of climate change and have significant capacity constraints, such as the least developed countries and the small island developing States, are eligible for funding from the Adaptation Fund to assist them in meeting the costs of adaptation, in accordance with decision 1/CMP.3, paragraph 1, mutatis mutandis;

IV. Sources of funding

- 10. *Decides* that when the Adaptation Fund serves the Paris Agreement it shall be financed by a variety of sources, public and private, including inputs from developed country Parties to the Convention, from [X] per cent of activities funded under the share of proceeds from the mechanism established by [Article 6] [Article 6, paragraph 4, of the Paris Agreement];
- 11. Requests the Adaptation Fund Board, in consultation with the interim trustee, to consider arrangements to implement the activities contained in paragraph [X] [above][below];
- 12. *Encourages* the provision of voluntary support that is additional to the sources mentioned in paragraph [X] above to provide funding to the Adaptation Fund;
- 13. *Recommends* that the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol decide that the Adaptation Fund will continue to be financed by the activities under Articles 6, 12 and 17 of the Kyoto Protocol;

V. Requests of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement to the Adaptation Fund Board

- 14. *Requests* the Adaptation Fund Board to consider the rules of procedure of the Board, the arrangements of the Adaptation Fund with respect to the Paris Agreement, and the implications of the Adaptation Fund to receive the share of proceeds from activities under Articles 6, 12 and 17 of the Kyoto Protocol after [1 January][31 December] 2020, with a view to forward recommendations to the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement at its 2nd session (November 2019).
- 15. [Requests the Adaptation Fund Board to review the operating modalities, policies and guidelines of the Adaptation Fund, including its environmental and social safeguards, antimoney laundering system, fiduciary risk management and disclosure policies and independent accountability mechanism, and to revise them as appropriate to ensure that the Adaptation Fund Board policies are in accordance with international best practices.]
- 16. *Requests* the Adaptation Fund Board to consider the need for possible changes to the operational modalities, policies and guidelines of the Adaptation Fund, and to forward recommendations to the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement at its 2nd session (November 2019).]

[The Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol,

Recalling decision 1/CMP.13,

I. Governance

- 1. Takes note of decision -/CMA.1 whereby the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement decided that the Adaptation Fund shall serve the Paris Agreement under the [authority and] guidance of, and be accountable to, the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement with respect to all matters relating to the Paris Agreement effective 1 January 2019¹;
- 2. [Decides that the Adaptation Fund shall exclusively serve the Paris Agreement and shall no longer serve the Kyoto Protocol effective [1 January][31 December] 2020;]

II. Composition of the Adaptation Fund Board

- 3. Also decides that further to decision 1/CMP.3, paragraph 6, the Adaptation Fund Board shall comprise members and their alternates representing Parties to the Kyoto Protocol and Parties to the Paris Agreement;
- 4. [Further decides that the Board shall comprise [X] additional members and their alternates representing Parties that contribute to the Adaptation Fund;]

III. Sources of funding

5. *Decides* pursuant to paragraph 2 above[, to consider, at its next session, whether] the Adaptation Fund shall continue to receive share of proceeds from activities under Articles 6, 12 and 17 of the Kyoto Protocol.

VI. Requests of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement to the Adaptation Fund Board
