Rationale

Across the Caribbean, private sector companies are increasingly aligning their operations with principles of sustainability, and the UN Sustainable Development Goals (SDGs). Despite this progress, access to appropriate financing remains a significant constraint for many small and medium-sized enterprises (SMEs). Limited capital, high financing costs, and insufficient knowledge of alternative funding mechanisms continue to challenge business' growth and innovation.

To address these challenges, the UN Global Compact Network Caribbean (Network Caribbean) in collaboration with Data Minders Business Research, the Caribbean Development Bank (CDB) and UN Framework Convention on Climate Change (UNFCCC) Regional Collaboration Centre (RCC) Caribbean will host a two-part series webinar entitled 'Empowering Caribbean Private Sector: Strengthening Proposal Development.'

This webinar series will provide participants with an introductory yet strategic overview of the funding landscape, donor expectations, and key components of a compelling grant proposal. The series will also enhance participants' capacity to engage effectively with donors, while identifying opportunities for further technical assistance and collaboration.

Goal

Strengthen private sector understanding of the financing landscape relevant to accessing grants to support sustainable business practices.

Objectives

- Enhance private sector capacity to develop results-oriented grant proposals.
- Promote awareness of sustainability financing opportunities and managing donor engagement.
- Highlight the tools, resources, and support available to private sector companies for accessing grant financing.
- Provide insights on opportunities for **private sector companies to align UN SDGs** into their business models.

Outcomes

- Improved readiness to pursue sustainable financing opportunities.
- Enhanced knowledge of proposal writing techniques and donor expectations.

Lead Facilitator: Tishana Simon, Independent Consultant

Tishana Simon is the Founder and Lead Research Consultant at **Data Minders Business Research** and has led the firm's research and proposal work since November 2016. She has delivered market research, economic analysis, and proposal development across the Caribbean. Project work includes completion of a funding proposal for the **Faith Based Network of Trinidad and Tobago**; a PANCAP grant submission involving desk reviews and filling proposal gaps through continuous client communication.

Data Minders was also awarded grant funding by the Caribbean Industrial Research Institute (CARIRI) under the Shaping the Future of Innovation programme (co-funded by the European Union and IDB Lab) to develop the Research Navigator minimal viable product. Tishana's core skills include grant and proposal writing, implementation planning, monitoring and reporting, and stakeholder engagement. She holds an MSc and BSc in Economics from the University of the West Indies and has completed additional training in competition policy, project management, and data science.
