## I. Introduction: What is the AC?

The Adaptation Committee (AC) is a constituted body under the UNFCCC and the leading body under the United Nations tasked by governments to provide coherence and guidance on adaptation, promoting synergy and strengthening engagement with national, regional and international organizations, centres and networks.



Through its decade of work, the AC has provided countries and other relevant stakeholders with technical expertise on adaptation, supporting governments to identify and address gaps and needs, as well as disseminating relevant information, knowledge, experience and good practices.



## **AC** areas of work

- The AC develops knowledge and technical guidance, and supports countries in the following areas:
  - Promoting overarching coherence on adaptation under the Convention and globally
  - Awareness-raising, outreach and information sharing on latest developments on adaptation
  - Adaptation planning and implementation, including:
    - Gaps and needs related to national adaptation planning and how to address them
    - Support for adaptation, including finance, technology and capacity-building
    - Good practices on adaptation
  - Providing technical support and guidance on reviewing subnational, national and overall adaptation progress, including:
    - Recognizing adaptation efforts of developing countries
    - Monitoring and evaluation of adaptation nationally and globally

# II. Accelerating adaptation action globally

- The **global momentum on adaptation** is growing as the world is increasingly impacted by climate change:
- UNSG Climate Action Summit 2019 launched the Call for Action: Raising Ambition for Climate Adaptation and Resilience (130 countries, selfgoverning territories and the European Union + 86 UN and other international organizations).
- UNSG Acceleration Agenda presented this year, aims to scale up finance and capacities for adaptation and loss and damage, including developing a road map to double adaptation finance before 2025.
- Processes under UNFCCC culminating at COP28: first Global Stocktake (GST), Glasgow-Sharm el-Sheikh work programme on the global goal on adaptation (GGA).

# **AC upcoming products: Country profiles**

- The AC is developing country profiles that will showcase the state of adaptation in each country of the world
- The profiles will focus on implemented adaptation actions and be structured along the adaptation cycle
- ❖The information will be based exclusively on national reports and communications submitted to the UNFCCC and be presented via an interactive online tool
- As a unique, central access point for information, the tool will enhance the collective understanding of adaptation, facilitate the recognition of adaptation efforts, stimulate learning and further action and enable the tracking of global adaptation progress
- ❖Together with the upcoming report on multilateral work on adaptation the profiles will kick off the AC's new information series on the global state of adaptation









## AC upcoming products: Work of the multilateral system

The state of adaptation of the multilateral system will showcase work by major intergovernmental organizations in support of countries' adaptation effort.



- The 2023 report will include relevant activities by a range of organizations, including the United Nations, MDBs, and key financial institutions.
- Analysis will be conducted along the adaptation policy cycle, thematic areas, and climate hazards.
- The aim of the report is to illustrate the landscape of major adaptation support efforts by the multilateral system, incubate new areas of thoughts through a forward-looking orientation, and explore opportunities for more coherent actions.





# III. Objective of this meeting

- This year, the AC is working towards launching longer-term work aimed at enhancing coherence across the intergovernmental architecture to support more ambitious worldwide adaptation action and collaboration.
- A number of specific activities are planned by the AC to this end, culminating in the upcoming 2023 Adaptation Forum (October 2023).
- This meeting at the ACW is the second in a series of regional engagement events and aims to foster a collaborative approach towards region-wide and transboundary adaptation action and support.



# IV. Expected outcomes

- Enhance a common understanding of the ongoing <u>region-wide and</u>
  <u>transboundary adaptation</u> efforts in the <u>Africa</u> region.
- Explore solutions, areas for collaboration, pathways towards stronger synergies, and opportunities to address gaps and needs aligning with the global adaptation agenda and ways in which the AC can support these efforts.
- Facilitate the dissemination and exchange of information between relevant stakeholders.
- Feed into the global longer-term work catalyzed under the Adaptation Forum.





# Summary of day 1 – short recap

- Three salient areas in which organizations are working on are education, EbA, and agriculture and water management
- Cross-cutting priorities include a gender-responsive approach, and leveraging technologies as well as local and indigenous knowledge
- Key success factors for collaboration include a locally-led, needs-based, participatory and inclusive approach; high-level political leadership; local ownership based on African priorities; multistakeholder partnerships; and strengthening of institutions.
- Other important elements for joint work include leveraging existing resources and social capital; learning from each other (e.g. South-South cooperation); capacity-building, M&E; and compliance mechanisms.
- Other ideas raised included enhancing policy alignment; data-sharing; mobilizing private finance for adaptation; and consideration of climate justice, peace and security.



# Preliminary findings from the survey on the landscape of Adaptation in Africa




