Presidency consultations on matters relating to adaptation (Further guidance in relation to the adaptation communications, including, inter alia, as a component of nationally determined contributions, referred to in Article 7, paragraphs 10 and 11, of the Paris Agreement)

## I. Decision<sup>1</sup>

The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement,

[Recalling relevant provisions of the Convention, including equity and the principle of common but differentiated responsibilities and respective capabilities[, in the light of different national circumstances,]]

[Also] recalling relevant provisions of the Paris Agreement, in particular its Article 7,

*Recognizing* the importance of flexibility provided to Parties by Article 7, paragraphs 10 and 11 of the Paris Agreement for submitting and updating the adaptation communication,

Recalling decisions 4/CP.5, 17/CP.8, and 5/CP.17,

*Recognizing* the links between adaptation and sustainable development, including the Sustainable Development Goals and the Sendai Framework for Disaster Risk Reduction,

*Emphasizing* the intrinsic relationship that climate change actions, responses and impacts have with equitable access to sustainable development and eradication of poverty,

*Recalling* that continuous and enhanced international support shall be provided to developing country Parties for the implementation of Article 7, paragraphs 7, 9, 10 and 11, of the Paris Agreement, in accordance with Articles 9, 10 and 11 of the Paris Agreement,

- 1. [Decides][Notes] that the purpose of the adaptation communication [may include][is] to:
  - (a) Increase the visibility and profile of adaptation [and its balance with mitigation];
  - (b) Strengthen adaptation action and support for developing countries [by developed country Parties];
  - (c) [Contribute to the global goal on adaptation and] Provide input to the global stocktake [in relation to Article 7.14 a and b];
    - (d) Enhance learning and understanding of adaptation needs and actions;
- 2. Adopts the guidance contained in the annex/decision;
- 3. [[Notes][Decides] that the adaptation communication is:] [Decides that principles of the adaptation communications are:]
  - (a) Country-driven and flexible, including in the choice of communication or document, as provided in Article 7, paragraphs 10 and 11, of the Paris Agreement;
  - (b) Not mandatory, [shall not]pose[s] [no][any] additional burden on developing country Parties, is not a basis for comparisons between Parties, and is not subject to a review;

(c) [Equity and common but differentiated responsibilities and respective capabilities in light of different national circumstances;]

[Recalls that according to the flexibility in Article 7, paragraphs 10 and 11, of the Paris Agreement, the adaptation communication shall be, as appropriate, submitted and updated periodically, as a component of or in conjunction with other communications or documents, including a NAP, an NDC as referred to in Article 4, paragraph 2, of the Paris Agreement and/or a national communication;]

[Recalls that as provided in Article 7, paragraphs 10 and 11, of the Paris Agreement, each Party should, as appropriate, submit and update an adaptation communication, and that the adaptation communication shall be, as appropriate, submitted and updated periodically, as a component of or in conjunction with other communications or documents, including a national adaptation plan, a nationally determined contribution as referred to in Article 4, paragraph 2 of the Paris Agreement and/or a national communication;]

- 5. *Decides* that Parties may, as appropriate, also submit and update their adaptation communication as a component of or in conjunction with the reports on impacts and adaptation as stipulated in Article 13, paragraph 8, of the Paris Agreement;
- 6. *Recalls* that the adaptation communications shall be recorded in a public registry maintained by the secretariat in accordance with the modalities and procedures contained in decision X/CMA.1;
- 7. *Invites* Parties who choose to submit an adaptation communication to do so in time to inform each global stocktake, as appropriate;

[[Decides][Takes note] that Parties can choose information communicated as a component of or in conjunction with an NDC on adaptation actions and/or economic diversification plans leading to mitigation co-benefits to be subject to review under Article 13, paragraph 7(b), of the Paris Agreement as established in decision -/CMA.1;]

[[Acknowledges][Takes note] that information communicated by Parties as a component of or in conjunction with an NDC on adaptation actions and/or economic diversification plans that result in mitigation co-benefits will be subject to review under Article 13, paragraph 7 of the Paris Agreement, as established in decision -/CMA.1;]

[Acknowledges that each Party with an NDC under Article 4 that contains adaptation actions and/or economic diversification plans that result in mitigation co-benefits consistent with Article 4.7, shall, with respect to such mitigation co-benefits:

- (a) Provide the information necessary for clarity, transparency and understanding in accordance with Article 4.8;
  - (b) Account for its NDC under Article 4 in accordance with Article 4.13; and
- (c) Provide the information necessary to track progress made in implementing and achieving its NDC under Article 4 as provided in Article 13.7(b);]
- 9. *Encourages* Parties to submit their adaptation communication, using the guidance contained in the annex/decision and considering, as appropriate, existing guidance for communications or documents used for the submission;
- 10. Acknowledges that Parties may, when submitting an adaptation communication, tailor the information provided, in consideration of the specific communications or documents used;
- 11. *Invites* Parties, according to their national circumstances and capacities, to provide in their adaptation communication information on the elements referenced {(A) to (D)} in the annex to this decision or in existing guidance as referred to in paragraph 9 above;
- 12. Also invites Parties to provide in their adaptation communication, inter alia, as appropriate, [additional] information on the elements numbered {(E) to (J)} in the annex to this decision;

- 13. Further invites Parties to include, as appropriate, [mainly] ex-ante or forward-looking information, based on the elements identified in the annex to this decision, in their adaptation communication, [with a particular focus on elements {(A) to (D)} in the annex to this decision];
- 14. *Encourages* Parties to clearly identify their adaptation communication, from the beginning to the end, regardless of the communication or document chosen in accordance with Article 7, paragraph 11, and number their adaptation communications sequentially;
- 15. Also encourages Parties that choose to submit an adaptation communication as a component of or in conjunction with an nationally determined contributions [as referred to in [Art.4.2][Art.7.11]] to include [ex-ante or forward-looking] information on any of the elements presented in the annex of this decision, as appropriate;
- 16. [*Invites* Parties that choose to submit their adaptation communication as part of the national communication or national adaptation plans may provide information [taking into consideration] [according to] the guidelines contained in document FCCC/CP/1999/7, decision 17/CP.8 and decision 5/CP.17 respectively;]
- 17. [*Invites* Parties that opt to use a nationally determined contribution consistent with Article 4.7, and in line with para 9 of decision -/CMA.1, to provide information on element (F) in the annex to this decision;]
- 18. [Agrees that, to contribute to achieving the global goal on adaptation, pursuant to Article 7, paragraph 14 of the Paris Agreement, it is necessary to have information that can be synthesized and that will enable enhanced action and improve the understanding of collective effort and progress towards the global goal on adaptation;]
- 19. [Requests the SBSTA to develop guidelines for use by Parties in communicating information under the elements contained in the annex/decision, with a view to adopting such guidelines at the third session of the CMA (November 2020). As input to the development of guidelines, it *invites* the IPCC to provide a technical paper on available methodologies for producing the information referred to in paragraph 18 above, with guidance from the SBSTA;]
- 20. *Decides* to take stock of, and if necessary revise:
  - (a) The guidance contained in the annex/decision, taking into account the submissions and the synthesis report referred to in paragraph 21 below, at its eighth session to be held in 2025;
  - (b) [The modalities presented in paragraph 16 above, in concurrence with the update/revision/review of the guidance for NDCs contained in the annex/decision XX;]
- 21. *Invites* Parties to submit to the secretariat, by 28 February 2025, information on their experiences with the application of the guidance contained in the annex/decision, and *requests* the secretariat to prepare a synthesis report of those submissions for consideration by the SBI at its sixty-second session, with a view to preparing recommendations to the CMA to inform the stocktake stipulated in paragraph 20 above;
- 22. [[Urges developed country Parties and] also invites Parties, United Nations organizations, specialized agencies, and other relevant organizations as well as bilateral and multilateral agencies, to continue to mobilize support for adaptation activities in developing country Parties;]
- 23. [Requests the GEF and the GCF, as the operating entities of the financial mechanism, to provide support to developing country Parties for the preparation and submission of their adaptation communications, [in line with their existing mandates];]
- 24. [Encourages the GCF, the GEF, the Adaptation Fund, the Climate Technology Centre and Network, and the Paris Committee on Capacity-building, in line with their existing mandates and governing instruments, to continue supporting developing country Parties in the implementation of their adaptation plans and actions, corresponding to the priorities and needs outlined in their adaptation communication;]

- 25. Takes note of the decision on matters referred to in paragraphs 41, 42 and 45 of decision 1/CP.21;
- 26. Takes note of the estimated budgetary implications of the activities to be undertaken by the secretariat referred to in this decision and requests that the actions called for in this decision be undertaken subject to the availability of financial resources.
