Report of the interim secretariat

Expected actions by the Board

The Board will be invited to take note of the report of the interim secretariat, including the execution of the administrative budget, and to provide guidance as necessary.

I. Background

- 1. The Conference of the Parties (COP) at its twenty-eighth session and the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA) at its fifth session decided to establish an interim secretariat for the Fund referred to in paragraphs 2–3 of decisions 2/CP.27 and 2/CMA.4 to provide support, including administrative support, to the Board of the Fund during the transitional period until the establishment of the independent secretariat. In this regard, the COP and the CMA requested the secretariats of the United Nations Framework Convention on Climate Change and the Green Climate Fund and invited the United Nations Development Programme to jointly form this secretariat.
- 2. This document provides a summary of the activities performed by the interim secretariat from 23 September to 22 November 2024. The annex to this document includes the report of the execution of the administrative budget up until 30 September 2024 (the annex will be issued as an addendum to this report).

II. Mandates to the interim secretariat

- 3. The table below summarizes the mandates of the interim secretariat arising from the decisions of the COP and the CMA, the Governing Instrument of the Fund for responding to Loss and Damage¹ and subsequent decisions of the Board, along with an overview on the work undertaken by the interim secretariat during the reporting period to implement its mandates.
- 4. At the second meeting of the Board (B.2) in July 2024, the Board adopted document FLD/B.2/9 titled "Workplan of the Board for 2024" and decided that it would be updated on a rolling basis to reflect new mandates.

III. Activities of the interim secretariat from 23 September to 22 November 2024

A. Additional activities of the interim secretariat

5. During the reporting period, the interim secretariat supported the ad hoc subcommittees in implementing their mandates. Key activities undertaken in this regard are summarized below.

1. Support to the ad hoc subcommittee on additional rules of procedures of the Board

6. The ad hoc subcommittee on additional rules of procedures of the Board has met three times during the reporting period (once during B.3 and twice between Board meetings) and was supported by the interim secretariat both during and between the meetings. The co-chairs of the ad hoc subcommittee have also met with the Co-Chairs, virtually. The ad hoc subcommittee focused on some of the outstanding issues as identified and reported to the Board at B.3 in September and converged on many of them. The interim secretariat also supported the co-chairs of the subcommittee in the conduct of written consultations with the Board on the draft additional rules of procedure from observers. The co-chairs of the subcommittee, with the support of the interim secretariat, prepared the final report on the work of the subcommittee including some final proposals for the draft additional rules of procedure. This was circulated to the ad hoc subcommittee on 11 November 2024. The subcommittee resolved many outstanding matters, leaving a handful of issues for consideration and decision by the Board, as part of the consideration at B.4 of the entire suite of additional rules of procedure.

2. Support to the ad hoc subcommittee on the administrative budget

- 7. During the reporting period, the interim secretariat provided continuous support to the ad hoc subcommittee on the administrative budget, which included preparation of background information and documents for its meetings, in the context of its consideration of the transition plan from the interim to the new independent Secretariat and the respective administrative budgets with a view of providing relevant recommendations to the Board.

Consultation with stakeholders regarding the participation of active observers in Board meetings and related proceedings, as part of the development of a Policy on Active Observers, including an observer accreditation process and the establishment of consultative forums, in accordance with relevant Board decisions
 - 8. The interim secretariat, in accordance with decision B.1/D.9, paragraph (d), and decision B.2/D.12, conducted an informal consultation on 17 September 2024, on the margins of B.3 in Baku, Azerbaijan, with the representatives of the nine observer constituencies of the United Nations Framework Convention on Climate Change to seek input for the development of the Policy on Active Observers, the observer accreditation

process and the establishment of consultative forums for engaging and communicating with stakeholders.

B. Collaboration with the independent Secretariat

9. Following the entry on duty of the Executive Director of the Fund, the interim secretariat established close collaboration with the independent Secretariat to ensure smooth transition. Close coordination between the teams was ensured through regular calls and inperson meetings on the margins of COP 29 and CMA 6 in Baku. During the reporting period, the collaboration focused on preparations for B.4, including with respect to the substantive papers, and on the elaboration of a transition plan from the interim to the independent secretariat.
